

**ESPN GIVEAWAY OF LAFC PLAYOFF TICKETS
OFFICIAL RULES**

***NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.
A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.***

1. HOW TO ENTER

- a. These rules govern the ESPN Giveaway of LAFC Playoff Tickets promotion (the "Promotion") being conducted by Good Karma Broadcasting, dba ESPN Los Angeles, 800 W. Olympic Blvd Suite 200, Los Angeles CA 90015 ("GKB") beginning on Monday, October 17, 2022, at 12:55pm Pacific and ending on Wednesday, October 19, 2022 at 4pm Pacific time.
- b. To participate in the Promotion, you may enter via the following method(s):
 - Listen to Mason & Ireland from 1-4pm Pacific Time on Monday, October 17 to Wednesday, October 19th and listen for the cue to call.
 - i. To participate in the Promotion, the authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each entrant must agree to GKB's online submission release in order to submit his or her entry.
 - ii. Sponsor is not responsible for winner notifications via texting that are the result of texting, computer or transmission errors and may cancel, modify or suspend the sweepstakes based upon any such error without liability at Sponsor's sole discretion. In the event than an error occurs and more than the designated number of prizes are claimed, the designated number of prizes will be awarded in a second round drawing from among eligible claimants.
- c. Only one (1) entry per fan is permitted.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 or older and who reside in the United States. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win.

Current or former employees, family members, agents, successors, or assignees of the client or any promotional agency involved with this promotion shall be INELIGIBLE to participate. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide identification valid driver's license, and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. Qualifying Prizes: Three (3) pairs of tickets to the LAFC Playoff Game at the Banc of California Stadium on 10/20/22. (\$300 retail value)
- b. Grand Prize: Winner and (1) guest will win two (2) pregame sideline passes to the 10/20/22 LAFC Playoff game. One winner will be randomly chosen from the three winners of the qualifying prizes. (\$200 retail value)
- c. There is no substitution, transfer, or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities, or any other expenses. Other restrictions may apply.
- d. Total Retail Value: \$500

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. The Grand Prize winners will be presented their prize on Wednesday, October 19, 2022
- c. Winners do have to listen to 710 ESPN to win.
- d. The winners must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited, and an alternate winner may be selected by the same method as above. If a

potential winner cannot be contacted, fails to sign, and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

- a. Payments of all federal, state, and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by GKB in a calendar year with an aggregate value of \$600 or more. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a

Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.

- f. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of GKB, any competition or prize-related event or travel is delayed, rescheduled, postponed, or cancelled, GKB reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Promotion and shall not be required to award a substitute prize.
- g. GKB is not responsible for typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize.
