1. HOW TO ENTER

- b. To participate in the Promotion, you may enter via the following method(s): Nominating a high school junior or senior that has above a 3.0 GPA and impact his or her community between Friday, June 16, 2023 at 8:00 AM PT and Friday, July 9th, 2023 at 12:00 AM PT. Nominations can be made at <https://goodkarmabrands.com/espn-la-contests/espn-la-all-star-students/>. To nominate a student, the nominator must include a photo of the student, the student’s GPA, the student’s high school name, a 500 description of the students impact on the community, the students email, an email address and phone number.
 - i. To participate in the Promotion, you may log onto <https://goodkarmabrands.com/espn-la-contests/espn-la-all-star-students/> and follow the links and instructions to enter the Promotion and submit your first and last name, telephone number, and a valid email address in the online entry form. Entry must include a photo of the student, the student’s GPA, the student’s high school name, a 500 description of the students impact on the community, the students email, an email address and phone number. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB.

GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each entrant must agree to GKB's online submission release in order to submit his or her entry.]

c. The nominator will be responsible to for all taxes associated with the prize and will need to complete an info verification before July 14th, 2023.

2. ELIGIBILITY RESTRICTIONS

GKB accepts no responsibility for repairing any real or supposed damage to any prize.
- b. All prizes will be mailed to the winners. The winner will forfeit any prize or prize certificate not claimed within five (5) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe

- b. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. On Friday, July 7th, the ESPN LA marketing team will meet and choose winners based on the quality of the applications.
- c. Winners will be recognized publicly following the first inning at the ESPN LA All-Star Friday Night Celebrity Baseball Game on Friday, July 14th at 7:05 PM PT.
- d. Odds of winning a Prize depends upon the number nominations received.
- e. The ESPN LA Marketing team will use fair judgment when choosing nominees. Our team will focus heavily on the 500 word submission. Our criteria for choosing a nominee will be based on the student's impact on the community. Each teammate will chose his or her top ten choices. Whoever receives the most votes from the 8 man panel will be named to the team. If there is a tiebreaker necessary, Tommy Lam will make the final decision.
- f. Qualifiers need not listen to ESPN LA to win. Winners need to be present to claim prizes.
- g. The ESPN LA Staff will contact winners directly. If the winner cannot be present during All-Star Friday Night on Friday, July 14th, he or she must forfeit the prize. The person who nominated the winner must execute and return any required affidavit of eligibility and/or liability/publicity release within three (3) days of winning or prize will be forfeited... and an alternate winner may be selected by choosing the nominee with the next amount of cumulative votes. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.
