

ESPN LA THE ULTIMATE WINERY EXPERIENCE SWEEPSTAKES (“Sweepstakes”)

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING. *This Sweepstakes is sponsored by Francis Ford Coppola Winery, 300 Via Archimedes, Geyserville, CA 95441 (“Sponsor”). Sweepstakes administrator is Good Karma Brands (“GKB”) 800 W. Olympic Blvd, Suite A-200, Los Angeles, CA.*

ESPN LA and Francis Ford Coppola Winery are giving fans the chance to win the Ultimate Winery Experience. Fans may enter the Sweepstakes online at <https://goodkarmabrands.com/francisfordcoppola/> between September 26, 2024 at 10:00 AM PST and October 13, 2024 at 11:59 PM PST (“Promotion Period”).

1. HOW TO ENTER

- a. These rules govern the ESPN LA The Ultimate Winery Experience Sweepstakes promotion beginning on September 26, 2024 at 10:00 AM PST and ending on October 13, 2024 at 11:59 PM PST.
- b. To participate in the Sweepstakes, you may enter via the following method(s): (1) by visiting a participating retail location, scanning the QR code, and completing the entry form, or (2) by visiting the website at <https://goodkarmabrands.com/francisfordcoppola/> and complete the online entry form during the Promotion Period and confirm eligibility requirements.
 - i. To participate in the Sweepstakes, you may log onto <https://goodkarmabrands.com/francisfordcoppola/> and follow the links and instructions to enter the Sweepstakes by submitting your first and last name, state, date of birth and a valid email address in the online entry form.
 - ii. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB’s computer is the official time keeping device for the Sweepstakes. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each entrant must agree to GKB’s online submission release in order to submit his or her entry.

2. ELIGIBILITY RESTRICTIONS

- a. The Sweepstakes is open to California residents who are 21 years of age or older.

The following individuals are also not eligible: employees, contractors, members, directors, managers and officers of Sponsor and GKB and each of its respective parent, affiliates, subsidiaries and web-design, advertising and promotion agencies, fulfillment, judging or other agency involved in the administration, development, fulfillment and execution of this Sweepstakes (collectively, "Parties"), and the immediate family members (parent, spouse, sibling, child, and their respective spouses or "step" of each, all lineal descendants, including those by adoption, regardless of where they reside) and those living in their same households whether or not related. Licensed distributors or retailers of alcoholic beverages, and their employees, are not eligible. Any individuals (including but not limited to employees, consultants, independent contractors, and interns) who, within the past six (6) months, performed services for Sponsor, agency or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Sweepstakes or supplying the prize, and/or their respective parent, affiliates, subsidiaries, and successor companies, and immediate family and household members of such individuals, are not eligible to enter or win. "Immediate family members" shall mean parents, stepparents, children, stepchildren, siblings, stepsiblings, or spouses. "Household members" shall mean people who share the same residence at least three months a year.

This Sweepstakes is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

- b. Listeners are eligible to win a prize in a promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

One (1) prize will be awarded in this Sweepstakes. The prize consists of a \$2500 Visa (or similar) gift card to book travel for two people to Charles M. Schulz – Sonoma County Airport and two nights' hotel accommodation. A tour of Francis Ford Coppola Winery is included in the prize. Reservations must be made in advance, for a mutually agreeable

date. Please contact GuestServices@francisfordcoppolawinery.com, to arrange your visit. Winner and their guest must be 21 years of age or older. Alcohol is not part of any prize.

The Approximate Retail Value (“ARV”) of the prize is \$2,500 maximum. Certain travel restrictions may apply. Prize is subject to availability. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and ground transportation to/from the airport and/or to/from the hotel, are the responsibility of the winner. The winner and travel companion(s) must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. If applicable, the winner may be required to present a valid credit card upon hotel check-in to cover any incidental expenses incurred during the winner’s stay. The winner and travel companion(s) must sign a Publicity, Liability Waiver and Travel Release form prior to traveling. If a selected event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, or for any reason beyond the control of GKB, GKB’s sole responsibility to the winner will be to award the remaining available portion of the prize and no substitution or compensation will be provided for the unawarded portion of the prize. GKB reserves the right to remove or to deny entry to the winner and/or travel companion(s) if either engages in a disruptive manner or with intent to annoy, abuse, threaten or harass any other person at Francis Ford Coppola Winery.

The winner will forfeit any prize or prize certificate not claimed within five (5) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.

There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Sweepstakes are final.
- b. GKB management will determine a winner by random drawing from all eligible entries received on or around Monday, October 14, 2024.
- c. Odds of winning the Sweepstakes depends upon the number of entries received.
- d. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within five (5) days of winning or prize will be forfeited and an alternate winner may be selected by the same method as above. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or

liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by GKB in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.
- b. By participating in the Sweepstakes, the winner agrees to have the winner's name, voice and likeness used in any advertising or broadcasting material relating to the Sweepstakes without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.

Prior to awarding any prize(s) or prize certificate(s), GKB, in its sole discretion, may require Sweepstakes winner(s) (and any travel companion(s) or guest(s)) to sign a liability release, agreeing to release and hold harmless GKB, Sponsor, their subsidiaries and affiliated entities, their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns from and against any and all claims or liability arising directly or indirectly from the prize and participation in the Sweepstakes.
- d. If for any reason this Sweepstakes cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Sweepstakes, or if the Sweepstakes is compromised or becomes technically corrupted in any way, electronically or otherwise, GKB reserves the right to cancel, terminate, suspend, or modify the Sweepstakes. If the Sweepstakes is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Sweepstakes may result in an entrant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f. GKB reserves the right to make changes in the rules of the Sweepstakes, including, without limitation, the substitution of a prize of equivalent value, which will become

effective upon announcement. If due to circumstances beyond the control of GKB, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, GKB reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Sweepstakes and shall not be required to award a substitute prize.

- g. GKB and Sponsor are not responsible for typographical or other errors in the printing, the offering or the administration of the Sweepstakes or in the announcement of a prize.
