

ESPN LA WILD CARD WATCH PARTY PROMOTION OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

ESPN LA – Good Karma Broadcasting, LLC, 800 W Olympic Blvd., Suite #200, Los Angeles CA, 90015 (“**GKB**”) is giving away the chance to get your food & beverage bill at Hollywood Park Casino 3883 W Century Blvd, Inglewood, CA 90303 covered on Saturday, January 10, 2026 (“Grand Prize”). Entrants may submit a raffle entry on Saturday, January 10, 2026, between 11:30am/PT and 2:30pm/PT. There will be a total of four (4) Grand Prize winners in the contest. The total ARV of each qualifying Grand Prize is \$125.

1. HOW TO ENTER

- a. These rules govern the ESPN LA WILD CARD WATCH PARTY PROMOTION (the “Promotion”) being conducted by ESPN LA – Good Karma Broadcasting, LLC, 800 W Olympic Blvd., Suite #200, Los Angeles CA, 90015 (“GKB”) beginning on Saturday, January 10, 2026 at 11:30am/PT and ending on Saturday, January 10, 2026 at 2:30pm/PT (“Promotion Period”).
- b. To participate in the Promotion, you may enter via the following method(s):
 - i. To participate in the Promotion, you may go to Hollywood Park Casino 3883 W Century Blvd, Inglewood, CA 90303 starting at 11:30am/PT and ending at 2:30pm/PT and complete the entry form provided by the ESPN LA team including first and last name, phone number, and email address. All entries must be received by Saturday, January 10, 2026 by 2:30pm/PT. GKB is not responsible for lost, stolen, mangled, misdirected, postage due, illegible, incomplete or late entries.
 - ii.
- c. One entry per person. There will be up to a total of four (4) entrants selected as a winner. Duplicate entries submitted will be disqualified.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 years and older and who reside in the Southern California region. Employees of GKB, its subsidiary and affiliated entities, GKB’s advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Entrants are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion. Participants

3. PRIZES

- a. There will be four (4) Grand Prizes awarded in this Promotion:

Grand Prizes consist of the following: the winner will receive the opportunity to have their food and beverage bill covered, up to a maximum of one hundred twenty-five dollars (\$125), at Hollywood Park Casino, 3883 W Century Blvd, Inglewood, CA 90303, during the ESPN LA Wild Card Watch Party. Coverage does not include gratuities. Any food and beverage charges in excess of \$125 are the sole responsibility of the winner.

The Approximate Retail Value ("ARV") of each prize is \$125.

The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- b. All prizes will be claimed on-site at the event. The winner will forfeit any prize or prize certificate not claimed within fifteen (15) minutes of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize.
- c. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. On Saturday, January 10, 2026, four (4) Grand Prize winners will be selected at random.
- c. Odds of winning a Grand Prize depend upon the number of submissions received. Odds of winning a Grand Prize depend upon the number of eligible entries received.

- d. Fans must be present at Hollywood Park Casino, 3883 W Century Blvd, Inglewood, CA 90303, during the ESPN LA Wild Card Watch Party event in order to claim the prize. Grand Prize winners must be present to win.
- e. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within twenty-four (24) hours of winning or prize will be forfeited. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize and GKB will draw another winner.

If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated

or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.

- f. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement.
