1. HOW TO ENTER

- a. These rules govern the ESPN LA DEWALT Giveaway being conducted by ESPN LA – Good Karma Broadcasting LLC, 301 W. Wisconsin Avenue, Suite 200, Milwaukee, WI 53203 (“GKB”) starting on Wednesday, September 11, 2024 at 10:00 AM through Wednesday, September 18, 2024 AT 11:59 PM.
- b. To participate in the Promotion, you may enter via the following method(s): submitting a picture through Instagram or Twitter (X) your team on the jobsite using the tag #MyDEWALT ToughTeam .
- c. Only one (1) internet entry per nominee.

Twitter does not restrict its account holders from running contests, sweepstakes or other promotions. The winner will forfeit any prize or prize certificate not claimed within one (1) day of winning. In the event that the prize is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss.
