

On the Tee Fantasy Golf Foursome

OFFICIAL RULES

Contest

ESPN Milwaukee will execute a contest to give away (1) fan foursome at the “On the Tee” golf event on Monday, October 11, 2021 at the Fairways of Woodside. On Monday, October 4, 2021 from 6-7pm CT during On the Tee, fans will be encouraged to call in during the weekly “Fantasy Golf” segment. Fans will be given the opportunity to tell Gabe and Stephen (show hosts) who they think the best fantasy golf foursome would be. The fan with the best response as determined by the show hosts will win the Grand Prize. The Grand Prize will consist of (1) foursome to The Fairways of Woodside to be used on Monday, October 11, 2021 at the On the Tee event at 12pm CT. The winner may invite up to (3) guests to participate in the foursome. The ARV of the Grand Prize is \$160.00.

1. HOW TO ENTER

- a. These rules govern On the Tee Fantasy Foursome (the “Promotion”) being conducted by WKTI 94.5 ESPN, 720 E Capitol Dr., Milwaukee, WI 53212 on Monday, October 4, 2021 from 6-7pm CT.
- b. To participate in the Promotion, you may enter via the following method(s):
 - Cue to Call during on-air local programming
 - i. To participate in the Promotion, you must listen to WKTI 94.5 ESPN on Monday, October 4, 2021 between the hours of 6-7pm CT for the announcement of the cue to call during the “Fantasy Golf” segment during On the Tee. Upon hearing the cue to call (as announced by the on-air personality prior to the cue to call), fans that get through to the GKB contest line at (800) 990-3776, will get to participate in the Fantasy Golf Foursome contest. Once prompted by the show hosts, fans can describe their best fantasy golf foursome. The caller with the best response as determined by Stephen and Gabe (show hosts) will be the winner upon confirmation of eligibility. At the time of their call, callers will be required to provide all information requested including their full name, complete address (including zip code), day and evening phone numbers, date of birth, and email address in order to be eligible to win. In the event that the selected caller is disconnected or is found to be ineligible, the show hosts will select the fan with the next best response to be the winner upon confirmation of eligibility. There is no limit to the number of times a listener may attempt to call in to win, but there will only be

- (1) winner selected during the Promotion. GKB is not responsible for telephone service outages, delays, busy signals, equipment malfunctions or any other technological difficulties that may prevent an individual from completing his/her telephone call. Due to delays in the GKB online streaming of its broadcast signal, listeners to the online stream may not be able to participate in or may be disadvantaged in participating in on-air contests.
- ii. Show times are subject to change based on breaking news and specialty content at the discretion of GKB. GKB has the right to not notify fans and to not update contest rules or the webpage when such situations occur.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are the age of 21 years and above and reside in the Greater Milwaukee Area. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, other radio stations in the Milwaukee metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

The Approximate Retail Value (“ARV”) of the first-place prize is \$160.00. - b. The On the Tee golf event will begin with a shotgun start at 12pm CT. The Grand Prize must be used at 12pm CT on Monday, October 11, 2021 or the prize will be forfeited and no alternate winner will be selected. To claim the Grand Prize, the winner must submit the name, phone number, and email address of all (4) participants in their foursome to GKB by Thursday, October 7, 2021 at 12pm CT. Any prize not claimed by Thursday, October 7, 2021 at 12pm CT will be forfeited. Once a fan has claimed their Grand Prize, it is up to the winner and all (3) guests to attend the On the Tee event on Monday, October 11, 2021 at 12pm CT. If the winner cannot attend the On the Tee event on Monday, October 11, 2021, they will forfeit their prize and no alternate prize will be awarded. - d. Qualifiers must listen to WKTI 94.5 ESPN to win. Prize winner need not be present to win.
- e. Winners will be notified by an employee of GKB via the phone number they provided to the show Producer within 24 hours of being selected the winner. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release including the names and requested contact information of all (4) participants in the fan foursome by Thursday, October 7, 2021 at 12pm CT or the prize will be forfeited. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.
