

FATPOUR TAP WORKS DRAFT WATCH PARTY SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. HOW TO ENTER

- a. These rules govern the Fatpour Tap Works Draft Watch Party Sweepstakes (the "Sweepstakes") being conducted by Good Karma Broadcasting LLC dba ESPN Chicago, 190 N State St Suite 700, Chicago, IL 60601 ("GKB") beginning on Thursday, April 24, 2025 at 7pm central time ("CT") and ending on Thursday, April 24, 2025 at 9pm central time ("Sweepstakes Period").
- b. To participate in the Promotion, you may enter via the following method: Attend a Draft Watch Party with ESPN Chicago at Fatpour Tap Works in Lincolnwood, IL and get a raffle ticket to be entered to win one (1) of four (4) prizes.

To participate in the Promotion, you must attend the Draft Watch Party with ESPN Chicago at Fatpour Tap Works located at 7244 Lincoln Ave, Lincolnwood, IL 60712. When you arrive, stop by the ESPN Chicago promotions table to get a raffle ticket for your chance to win one (1) of three (3) ESPN Chicago branded Ice Shaker water bottles or a signed Montez Sweat mini-helmet and \$100 Fatpour Tap Works gift card. There will be a total of up to four (4) winners. At the time of their entry, entrants will be required to provide all information requested including their full name, day and evening phone numbers, email, and date of birth in order to be eligible to be an entrant.

- c. One (1) entry per person. You may have a maximum of one (1) win per Sweepstakes Period. Prize can only be won by being a winner during the Sweepstakes Period.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are **18 or older** and who reside in the United States of America. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

- b. Up to one (1) win per person per Sweepstakes Period. Entrants are eligible to win a prize in only one (1) sweepstakes or promotion conducted by GKB, including this Sweepstakes, once every seven (7) days and once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. Entrants are required to provide truthful information. GKB will reject and delete any entry that it determines, in its sole and absolute discretion, to be false or fraudulent. GKB will disqualify any Entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. Up to four (4) prizes will be given away.

The prizes awarded at 7:30pm CT, 8pm CT, and 8:30pm CT during the Sweepstakes Period will each be one (1) ESPN Chicago branded Ice Shaker Water Bottle with an approximate retail value ("ARV") of \$34.99 each.

The prize awarded at 9pm CT during the Sweepstakes Period will be one (1) signed Montez Sweat mini-helmet and a \$100 Fatpour Tap Works gift card with an ARV of \$219.

Each Prize Winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. The gift card(s) will be subject to the terms and conditions as set forth by the issuer of the gift card(s). GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- b. Prize fulfillment will be handled via email. The winner will forfeit any prize or prize certificate not claimed within seven (7) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- c. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. Each Prize Winner will be randomly selected.

- c. All Prize Winners will be selected by 9pm CT on Thursday, April 24, 2025.
- d. The odds of being a Prize Winner depends on the order and number of calls received.
- e. Prize winners must be present to win.
- f. The winners must execute and return any required affidavit of eligibility and/or liability/publicity release within seven (7) days of winning or prize will be forfeited. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by GKB in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.
- b. By participating in the Promotion, the winner agrees to have the winner's name, voice and likeness used in any advertising or broadcasting material relating to the Promotion without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.

Prior to awarding any prize(s) or prize certificate(s), GKB, in its sole discretion, may require Promotion winner(s) (and any travel companion(s) or guest(s)) to sign a liability release, agreeing to release and hold harmless GKB, its subsidiary and affiliated entities, their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns from and against any and all claims or liability arising directly or indirectly from the prize and participation in the Promotion.
- d. If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, GKB reserves the right to

select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).

- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of GKB, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, GKB reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Promotion and shall not be required to award a substitute prize.
- g. GKB is not responsible for typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize.
