

ESPN Wisconsin Free Throw Knockout Competition 2019

OFFICIAL RULES

CONTEST OVERVIEW

ESPN Wisconsin will execute a contest to give away one hundred (100) spots for fans to participate in the Free Throw Knockout Contest on Sunday, March 24, 2019. The Free Throw Knockout Contest includes the opportunity to shoot on the court at Fiserv Forum and prizes for the top three finishers. Fans can enter for the chance to win via an online entry form at ESPNWisconsinContests.com between the dates of Monday, March 4, 2019 and Friday, March 15, 2019. A total of (100) winners will be selected on Monday, March 18, 2019.

1. HOW TO ENTER

- a. These rules govern The Free Throw Knockout Competition promotion (the "Promotion") being conducted by WAUK 540 AM and WKTJ 94.5 ESPN FM, 720 E Capitol Dr., Milwaukee, WI 53212 and WTLX 100.5 FM ESPN, 15 N Pinckney St, Madison, WI 53703 ("GKB") beginning on Monday, March 4th, 2019 at 9 AM CST and ending on Friday, March 15th, 2019 at 5 PM CST.
- b. To participate in the Promotion, you may enter via the following method(s):
 - Register online at ESPNWisconsinContests.com
 - i. To participate in the promotion, you may log onto ESPNWisconsinContests.com and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of the entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address of the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 years of age and above as well as those under the age of 18 if accompanied by an adult and provided with a liability form signed by the parent or guardian, and who reside in the state of Wisconsin. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, [other radio stations in the Milwaukee and Madison metropolitan areas and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every thirty (30) days and only once every six (6) months if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements. GKB will also delete any entry knowingly received from persons under the age of 13 in compliance with the Children's Online Privacy Protection Act.

3. PRIZES

- a. Prizes will be awarded in this Promotion. Each prize consists of the following:
 - Qualifying Prize - One spot in the Free Throw Knockout Competition on March 24th, 2019 at the Fiserv Forum. All Free Throw Knockout qualifiers will receive two tickets to the Bucks game that afternoon and a Cousins Sub offer card to redeem at the stadium during the game.

Out of the Qualifying Prize winners, there is the opportunity to win a Grand Prize for First, Second, or Third place, which includes the following in addition to the Qualifying Prize:

- First Place Winner: Cousins Subs for a year (\$312 value), an 18/19 Bucks Team Signed Ball, and pregame recognition at the Bucks game that afternoon.
- Second Place Winner: a Malcolm Brogdon signed photo and a \$100 Cousins Subs gift card.
- Third Place Winner: a Kareem Abdul-Jabbar Signed plaque, and a \$50 Cousins Subs gift card.

The Approximate Retail Value ("ARV") of each Qualifying Prize is \$64; first prize is \$576, second prize is \$240 and third prize is \$265. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- b. All prizes or prize certificates will be given to the winners the day of the event at the Fiserv Forum. The winner must confirm that he/she will attend the event/game by the end of the day on Wednesday, March 20th, 2019, or he/she will forfeit the prize and another winner will be selected at random from the pool of entries from the online form. In addition, the winner will forfeit any prize or prize certificate not claimed on March 24th, 2019. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- c. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. Participants will be notified by Monday, March 18th, 2019 if they have been selected to participate in The Free Throw Knockout Competition.
- c. Participants must RSVP by 5 PM CST Wednesday, March 20th, 2019, or else the prize will be forfeited and another winner will be randomly selected in their place.
- d. Participants must be present to qualify to receive the prizes on Sunday, March 24th, 2019.
- e. Odds of winning a qualifying prize depends upon the number of entries in this competition. Odds of a qualifier winning the top three prizes on-site are dependent on the skill of each participant.
- f. Promotion of Skill:
 - The structure of the game is defined as followed:
 - Round One: Each participant will be allowed to shoot two free throws. The participant is only required to make one of two free throws to advance to the next round.

- Round Two: Each participant will be required to make one of one free throws to advance to the third round.
 - Round Three: The participant is allowed to only one free throw and must make it to advance. In the event, the competition is still on at 9:45 AM time, the remaining participants will shoot from the three-point line with one shot in the Knockout format.
- g. Qualifiers must be present day of the event during the specified times in order to win any of the prizes.
- h. All Free Throw Knockout qualifiers will be notified they have been selected to compete by phone, with the phone number they provided on their online submission form. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release by March 23rd, 2019, at 5 PM CST. Extra copies will be provided on-site on Sunday, March 24th and must be completed prior to participation. Any paperwork not submitted at this time will result in the prize being forfeited with no replacement. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes.
