

ESPN New York & All American Ford – Bronco Giveaway Promotion

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

ESPN New York and All American Ford are giving away a two (2) year lease on a 2023 Ford Bronco. Fans may enter during DiPietro & Rothenberg, weekdays between Monday, May 22, 2023 and Friday, June 9, 2023. There will be a total of thirty (30) qualifying prizes and one (1) grand prize in the contest. The total ARV of all prizes are \$37,172.96.

1. HOW TO ENTER

- a. These rules govern the ESPN New York & All American Ford – Bronco Giveaway Promotion (the “Promotion”) being conducted by Good Karma Broadcasting LLC, ESPN New York, 880 3rd Ave, 12th Floor, New York, New York 10022 (“GKB”) beginning at 6:00 AM ET on Monday, May 22, 2023 and ending at 7:00 PM ET on Friday, June 30, 2023.
- b. To participate in the Promotion, you may enter via the following method(s):
 - i. Listen to 98.7 FM – WEPN – ESPN New York during DiPietro & Rothenberg (between 6:00 AM ET and 10:00 AM ET) weekdays beginning on Monday, May 22, 2023 and ending on Friday, June 9, 2023 for the announcement of the cue to call the GKB Caller Line at 1-800-919-3776 during the rotating features listed below in the 8:00 AM ET hour.
 - a. Fact or Fiction – Callers will have to correctly answer two (2) out of three (3) 50/50 questions.
 - b. Stump Rothenberg Questions – On-air personalities will judge each caller on creativity, humor & relevance.
 - c. Morning Roasts – On-air personalities will judge each caller on creativity, humor & relevance.
 - d. Is This A Real College – On-air personalities ask callers to name the real college out of three (3) choices. Callers will have to correctly answer two (2) out of three (3) questions.
 - e. All American Feud – On-air personalities will judge each caller on creativity, humor & relevance.
 - f. Did it Happen in America – Callers will have to correctly answer two (2) out of three (3) questions.

After announcing the cue to call, the on-air personalities will take callers on air to participate in the daily feature. In the event that the selected caller is

- disconnected or is found to be ineligible, the next eligible caller that successfully makes it through on the GKB Caller Line will participate. Callers will be judged at the on-air personalities' discretion based on accuracy, creativity, humor and relevance for the chance to win two (2) VIP passes to the ESPN New York Beach Bash event on Friday, June 30th, 2023 at Bar Anticipation in Lake Como, NJ and one (1) qualifying entry for the chance to win a two (2) year lease on a 2023 Ford Bronco 2-Door 4x4 upon confirmation of eligibility.
- ii. Listen to 98.7 FM – WEPN – ESPN New York during DiPietro & Rothenberg (between 6:00 AM ET and 10:00 AM ET) weekdays beginning on Monday, May 22, 2023 and ending on Friday, June 9, 2023 for the announcement of the cue to call the GKB Contest Line at 1-888-987-3776 during the D&R Trivia segment in the 9:00 AM ET hour. Upon hearing the cue to call, the designated number caller (as announced by the on-air personality prior to the cue to call) to get through to the GKB Contest Line and correctly answer the daily D&R Trivia Question will win two (2) VIP passes to the ESPN New York Beach Bash event on Friday, June 30th, 2023 at Bar Anticipation in Lake Como, NJ and one (1) qualifying entry for the chance to win a two (2) year lease on a 2023 Ford Bronco 2-Door 4x4 upon confirmation of eligibility. In the event that the selected caller is disconnected or is found to be ineligible, the next eligible caller that successfully makes it through on the GKB Contest Line with the correct answer to the D&R Trivia Question and completes their call will be a winner.
 - c. At the time of their call, callers will be required to provide all information requested including their full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once. There will be up to a total of thirty (30) winners selected on-air during the Promotion dates. GKB is not responsible for telephone service outages, delays, busy signals, equipment malfunctions or any other technological difficulties that may prevent an individual from completing his/her telephone call. Due to delays in the GKB online streaming of its broadcast signal, listeners to the online stream may not be able to participate in or may be disadvantaged in participating in on-air contests. Show times are subject to change based on breaking news and specialty content at the discretion of GKB. GKB has the right to not notify fans and to not update contest rules or the webpage when such conditioners occur.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 years of age or older as of entry and who reside in the New York City metropolitan area (NY, NJ, CT, PA). Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, other radio stations in the New

York City metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.

 - Two (2) VIP passes to the ESPN New York Beach Bash event on Friday, June 30th, 2023 at Bar Anticipation in Lake Como, NJ.
 - One (1) qualifying entry for the chance to win a two (2) year lease on a 2023 Ford Bronco 2-Door 4x4.

One (1) Grand Prize will be awarded in this Promotion. Prize consists of the following:

- Two (2) year (7,500 miles per year) lease on a 2023 Ford Bronco
 - 2-Door 4x4 Big Bend
 - 4 Passenger
 - 2.3L Ecoboost I-4 Engine
 - 10-Speed Automatic Transmission

The Approximate Retail Value (“ARV”) of the qualifying prizes are: \$200.00.

The Approximate Retail Value (“ARV”) of the Grand Prize is: \$31,172.96.

Under no circumstances will the total ARV of all prizes exceed \$37,172.96.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. Qualifiers will be selected during DiPietro & Rothenberg (between 6:00 AM ET and 10:00 AM ET) weekdays beginning on Monday, May 22, 2023 and ending on Friday, June 9, 2023.
- c. The Grand Prize winner will be randomly selected from all qualifiers present at The ESPN New York Beach Bash event on Friday, June 30, 2023 at Bar Anticipation in Lake Como, NJ (between 12:00 PM ET and 7:00 PM ET). Thirty (30) qualifiers from this promotion and one (1) qualifier from the "Build Rick's Ride" promotion must be present at The ESPN New York Beach Bash event to be eligible for the Grand Prize.
- d. Odds of winning the Qualifying Prize depends upon the number and order of calls received. Odds of winning the Grand Prize depends on the number of qualifiers present at the ESPN New York Beach Bash event. If all qualifiers are present at the event on June 30, 2023, odds of winning the Grand Prize are 1 in 31.
- e. Winners must listen to 98.7 FM – WEPN – ESPN New York to qualify.
- f. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within three (3) business days or prize will be forfeited and an alternate winner may be selected. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
