The total ARV of the prize(s) is/are \$12,544.00.

1. HOW TO ENTER

- a. - b. To participate in the Promotion, you may enter via the following method(s):
 - i. To participate in the Promotion, you may access the contests pages on espnnewyork.com and the ESPN New York App and follow the links and instructions to enter the Promotion and submit your first and last name, city, state, telephone number, date of birth and a valid email address in the online entry form. Internet and app entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB’s computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each entrant must agree to GKB’s online submission release in order to submit his or her entry. Only one internet or app entry per person and one internet or app entry per email address is permitted.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 years of age or older as of entry and who reside in the New York City metropolitan area (NY, NJ, CT, PA).

Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, other radio stations in the New York City metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

Under no circumstances will the total ARV of all prizes exceed \$12,544.00.

- b. On Monday, June 9, 2025, ESPN New York's Marketing team will randomly select winners within the New York City metropolitan area (NY, NJ, CT, PA) that meet all eligibility requirements.

- e. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within five (5) business days from being contacted or prize will be forfeited and an alternate winner may be selected by the same method as above. - e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes.
