

ESPN New York & Live Nation – Linkin Park Tickets - Digital Entry Promotion

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

ESPN New York & Live Nation are giving away Linkin Park Tickets. Fans may enter on the ESPN New York App and at ESPNNewYork.com between Thursday, November 14, 2024, and Friday, November 22, 2024. There will be a total of ten (10) prizes in the contest. The total ARV of the prize(s) is/are \$1,590.00.

1. HOW TO ENTER

- a. These rules govern the ESPN New York & Live Nation – Linkin Park Tickets - Digital Entry Promotion - Digital Entry Promotion (the “Promotion”) being conducted by Good Karma Broadcasting LLC, ESPN New York, 575 Lexington Ave, 14th Floor, New York, New York 10022 (“GKB”) beginning at 6:00 AM ET on Thursday, November 14, 2024 and ending at 11:59 PM ET on Friday, November 22, 2024.
- b. To participate in the Promotion, you may enter via the following method(s):
 - i. To participate in the Promotion, you may access the contests pages on espnnewyork.com and the ESPN New York App and follow the links and instructions to enter the Promotion and submit your first and last name, city, state, telephone number, date of birth and a valid email address in the online entry form. Internet and app entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB’s computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each entrant must agree to GKB’s online submission release in order to submit his or her entry. Only one internet or app entry per person and one internet or app entry per email address is permitted.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 years of age or older as of entry and who reside in the New York City metropolitan area (NY, NJ, CT, PA).

Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, other radio stations in the New York City metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.

One (1) pair of tickets to Linkin Park at choice of Barclays Center on July 29, 2025 or Prudential Center on August 3, 2025.

The Approximate Retail Value ("ARV") of Barclays Center tickets are: \$119.00.
The Approximate Retail Value ("ARV") of Prudential Center tickets are: \$199.00.
Under no circumstances will the total ARV of all prizes exceed \$1,590.00.

The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- b. All prizes or prize certificates may be picked up at the office of GKB at the address below. The winner will forfeit any prize or prize certificate not claimed within five (5) business days. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- c. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. On Monday, November 25, 2024, ESPN New York's Marketing team will randomly select winners within the New York City metropolitan area (NY, NJ, CT, PA) that meet all eligibility requirements.
- c. Odds of winning the prize depends upon the number of entries received.
- d. Winner need not be present to win.
- e. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within five (5) business days from being contacted or prize will be forfeited and an alternate winner may be selected by the same method as above. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
