

## Contest and Promotion Rules for ESPN West Palm

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.**

Unless otherwise specified **ESPN West Palm, 777 South Flagler Dr Suite 106, West Palm Beach, FL 33401** (“GKB”), these rules cover routine contests and promotions conducted by GKB. These rules may be amended by separate specific rules for major contests or promotions conducted by GKB or its sponsors.

The contest or promotion (the “Promotion”) will take place during the dates and times specified in the official rules of the Promotion (the “Promotion Period”) or as announced by GKB. GKB may change the dates and/or terms of the Promotion without prior notice. [Any material changes will be broadcast on the Station and, if applicable, posted on its website located at **www.espnwestpalmcontests.com**.

Due to delays in the online streaming of GKB’s broadcast signal, listeners to the online stream may not be able to participate in or may be disadvantaged in participating in certain Promotions. Entrants are encouraged to listen to **ESPN West Palm 106.3FM** on-air. GKB is not responsible for online streaming delays.

To be eligible to enter or participate in the Promotion, GKB listeners/customers must follow the instructions set forth in the official rules of the Promotion or as announced and must fulfill all of the eligibility requirements of the Promotion. Unless otherwise specified, the Promotion is open to all persons who are legal U.S. residents **18 and older** and who reside in **West Palm Beach / Treasure Coast Area**. Void where prohibited or restricted by law. Employees of GKB, its subsidiary and affiliated entities, its advertising and promotional agencies, its participating sponsors, and the members of their immediate families [spouse, parents, siblings, or children) and/or households are ineligible to participate or win. Participants are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days, and participants are eligible to win a prize in a Promotion conducted by GKB only once every six (6) months if the prize is valued over \$600. Only one winner per household is permitted in any GKB-conducted Promotion. For on-air Promotions, there is no limit to the number of times a listener may attempt to call-in or text; however a listener may only qualify once.

Promotion prizes and their values will be indicated when GKB announces the Promotion. Unless otherwise announced, all prizes or prize certificates must be picked up at the offices of GKB **777 South Flagler Dr Suite 106, West Palm Beach, FL 33401**. Prizes may be claimed during regular business hours (between 8:00am and 5:00pm, Monday through Friday). Promotion winner(s) will be required to present valid

government-issued photo identification and provide winner's complete address, date of birth and phone number to claim a prize. Unless otherwise permitted by GKB, winner(s) must claim his or her prize(s) in person, and a prize cannot be claimed by third parties on behalf of the winner. If a Promotion is open to entrants under the age of 18 and a winner is under the age of 18, a parent or legal guardian must claim the prize. Decisions of GKB management with respect to the Promotion are final.

Promotion winner(s) must execute and return any required Affidavit of Eligibility and/or Release of Liability Prize Acceptance Form within seven (7) days of winning or being notified of winning or prize will be forfeited and an alternate winner may be selected. GKB reserves the right to cancel, terminate, suspend, or modify the Promotion as it deems necessary if it is not capable of completion as planned, including, without limitation, as a result of infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. # GAINBRIDGE TICKET GIVEAWAY

## OFFICIAL RULES

***NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.***

### 1. HOW TO ENTER

- a. These rules govern the promotion being conducted by **ESPN West Palm** (“GKB”) beginning on **January 24th, 2022 at 12PM ET** and ending on **Sunday January 30th at 8PM ET**.

- b. To participate in the Promotion, you may enter via the following method(s):

**Participants may enter on Josh Cohen & The HomeTeam with Din Thomas and Tina by calling into the show and participating in TuneDorks: a show where Din and Josh go head to head in a Name that Tune game. Josh plays on behalf of one caller, Din plays on behalf of the other. The player representing the winning teammate, wins.**

**Participants may enter on Ken LaVicka live by calling in when the cue to call is given. Fans will be told to be caller number 3 to win.**

**Participants may enter via Facebook on the designated Gainbridge LPGA post and commenting the cue word, “GAINBRIDGE” to enter.**

- i. To participate in the Promotion, you must listen to **WUUB 106.3FM** day beginning on **Monday January 24<sup>th</sup>**, and ending on **Sunday January 30<sup>th</sup>**. between the hours of **12p-6p** each day for the announcement of the cue to call. Upon hearing the cue to call, the designated number caller (as announced by the on-air personality prior to the cue to call) to get through to the GKB contest line will win **a 4-pack of general admission tickets to the LPGA Gainbridge Tournament** upon confirmation of eligibility. At the time of their call, callers will be required to provide all information requested including their full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. In the event that the selected caller is disconnected or is found to be ineligible, the next eligible caller that successfully makes it through on the call-in line and completes their call will be a winner.
