Contest

ESPN Milwaukee is giving fans a chance to Golf with Homer & Gabe on Tuesday, September 17th, 2019 at Morningstar Golfers Club. Fans will have from Monday, August 26th, 2019 until Sunday, September 8th, 2019 to submit an online entry at www.espnwisconsincontests.com for their chance to win Golf with Homer & Gabe. One winner will be selected at random and contacted on Tuesday, September 10th, 2019. The winner will be allowed to bring a guest of their choice to participate in the event.

1. HOW TO ENTER

- a. These rules govern the Golf with Homer & Gabe promotion (the "Promotion") being conducted by ESPN Milwaukee, WKTI 94.5 ESPN, 720 E. Capitol Dr., Milwaukee, WI 53212 ("GKB") beginning on Monday, August 26th, 2019 at 6:00am CST and ending on Sunday, September 8th, 2019 at 11:59pm CST.
- b. To participate in the Promotion, you may enter via the following method(s):
 - Submit an online registry on www.espnwisconsincontests.com
 - i. To participate in the Promotion, you may log onto www.espnwisconsincontests.com and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. There will be one (1) winner selected online for The Promotion. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other

technological problems. Each entrant must agree to GKB's online submission release in order to submit his or her entry.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 years of age or older and who reside in Wisconsin. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, other radio stations in the Milwaukee metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every thirty (30) days and only once every six (6) months if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.

3. PRIZES

- a. (1) grand prizes will be awarded in this Promotion. Each prize consists of the following:
 - You and a guest get to golf with Homer & Gabe at Morningstar Golfers Club on Tuesday, September 17th, 2019
 - 2 drink tickets (can be applied for soda, water, and Gatorade if under 21)
 - Lunch with Homer & Gabe

The Approximate Retail Value ("ARV") of the prize is \$150. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- b. All prizes or prize certificates may be called and emailed to the winner. The winner must RSVP by Thursday, September 12th, 2019 and will forfeit any prize or prize certificate not claimed on-site on Tuesday, September 17th, 2019. In the event that a prize or prize certificate is mailed to the winner, it will be with the

prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.

- c. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. The winner will be selected on Tuesday, September 10th, 2019. The winner will be notified via phone and will be emailed all prize details. The winner must RSVP with his/her guest name by Thursday, September 12th, 2019.
- c. Odds of winning depends upon the number of entries.
- d. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release by Thursday, September 12th, 2019 or prize will be forfeited and an alternate winner may be selected. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
