

## Home & Away with Golic & Wingo Promotion

### OFFICIAL RULES

#### CONTEST:

Fans can enter for the chance to win a VIP Golic and Wingo experience both “home and away.” One winner will be randomly selected from the pool of online entries that Good Karma Brands (“GKB”) receives. The winner and their one (1) guest will receive a trip from Milwaukee to Bristol, CT to view a live taping of Golic and Wingo along with additional VIP experiences at ESPN Headquarters. In addition, the winner and guest will get to view a live local taping of Golic and Wingo at the Tundra Trio in Green Bay, WI on September 7, 2018 with a VIP experience to follow the taping. To register for a chance to win, fans must fill out the online entry form on [ESPNWisconsinContests.com](http://ESPNWisconsinContests.com). The one winner will be selected on Thursday, August 23, 2018.

#### 1. HOW TO ENTER

- a. These rules govern the Home & Away with Golic & Wingo (the “Promotion”) being conducted by ESPN Milwaukee, 310 W. Wisconsin Ave. Suite 100 Milwaukee, WI 53203 (“GKB”) beginning on Wednesday, August 1, 2018 and ending on Tuesday, August 21, 2018.
- b. To participate in the Promotion, you may enter via the following method(s): Go to [ESPNWisconsinContests.com](http://ESPNWisconsinContests.com) and complete the online registration form in full.
  - i. To participate in the Promotion, you may log onto [ESPNWisconsinContests.com](http://ESPNWisconsinContests.com) and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth and a valid email address in the online entry form. You must also confirm and agree to the official contest rules and event liability. NOTE: There will be a required field that will allow entrants to opt in to ESPN Milwaukee’s newsletter and the Axiom newsletter by Annex Wealth Management. Choosing to opt-in to this newsletter is not required and will not improve the chances of winning. All entries are eligible regardless of opt in. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB.

GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems.

## 2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 or older and who reside in the Greater Milwaukee Area. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, other radio stations in the Greater Milwaukee metropolitan area, the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize. In addition, for booking travel (airfare and car service) as well as hotel, the winner must provide us any other needed information at those times.
- c. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

- a. One Grand Prize will be awarded in this Promotion. The prize consists of the following:
  - b. Away with Golic & Wingo: Airfare for two (2) fans departing and arriving from General Mitchell International Airport to the airport in Hartford, CT;
  - c. \$300 gift card for incidentals during travel
  - d. Sit in on a live taping of Golic & Wingo
  - e. A customized VIP ESPN Headquarters experience with the opportunity for the winner and guest to voice their own promo with one of the Golic & Wingo show team producers; sit in on a live taping of Golic & Wingo; lunch with members of the ESPN team;
  - f. One (1) night stay – standard room, double occupancy in Sponsor sole discretion.
  - g. Winner must take the trip by October 31, 2018 or subject to forfeit prize.

Home with Golic & Wingo:

- h. The Prize also includes: viewing of a local live taping of Golic & Wingo at the Tundra Trio in Green Bay on Friday, September 7 with a VIP experience.

The Approximate Retail Value (“ARV”) of the prize is \$1,750 (TBD). Total prize will be over \$600. The winner will be solely responsible for all taxes and other fees and expenses not specified herein associated with the receipt and use of the Prize, including transportation to and from General Mitchell International Airport and to and from Green Bay.

- i. All prizes or prize certificates may be picked up at the office of GKB at the address below. The winner will forfeit any prize or prize certificate not claimed within forty-five (45) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- j. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. #### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. One winner will be chosen at random from the eligible online entries on Thursday, August 23, 2018 by 5:00 PM CST.
- c. The final winner will be determined on Friday, August 24, 2018 by 5:00 PM CST once we confirm the winner can visit Golic & Wingo at the Tundra Trio on Friday, September 7 and take a trip to Bristol before October 31, 2018.
- d. Odds of winning are dependent on the number of online entries received.
- e. Grand prize winner does not need to listen to WAUK 540 ESPN in order to win or be present.
- f. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited and an alternate winner may be selected out of the online entries at random again. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
