

JACK DANIEL'S SCAN-TO-WIN CONTEST

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

On select days over the next three months, 850 ESPN Cleveland and Jack Daniel's will be giving fans a chance to win a Jack Daniel's cooler prize pack. The ESPN Cleveland Street Team will be at Collision Bend Brewing Company in The Flats East Bank on every Browns' weekend home game. Fans must stop by the street team to scan a QR code and fill out the online register-to-win form for a chance to win the prize pack. The Promotion will begin Sunday, October 9, 2022, and end on Sunday, December 18, 2022. One (1) winner will be randomly selected on the next business day after each Browns' weekend home game. There will be a total of five (5) winners. Must be 21 years of age or older at time entry to be eligible to win. The ARV of each prize pack is \$300.

1. HOW TO ENTER

- a. These rules govern the Jack Daniel's Scan-to-Win Contest (the "Promotion") being conducted by ESPN Cleveland, 1109 Old River Road, Cleveland, OH 44113 ("GKB") beginning on Sunday, September 22, 2022 at 4:00PM EST and ending on Sunday, December 18, 2022, at 11:59PM EST.
- b. To participate in the Promotion, you may enter via the following method:
 - Locate a Jack Daniel's QR code alongside our ESPN Cleveland Street Team at Collision Bend Brewing Company in The Flats East Bank. Scan the QR Code and complete the online register to win form on the redirected webpage at www.ESPNclevelandContests.com.
 - i. To participate in the Promotion, fans must visit the ESPN Cleveland Street Team at Collision Bend Brewing Company on Browns' weekend home games, scan the designated QR code, and follow the link and instructions on the redirected webpage to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted each Browns home gameday. **Note:** All entries received each game will expire once a winner has been selected. Fans will be allotted re-entry if they do not win the week they enter and re-visit the ESPN Cleveland Street Team on the next Browns' weekend home game until the end of the Promotion. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning

an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each entrant must agree to GKB's online submission release in order to submit his or her entry.

- c. Only one internet entry per person and one internet entry per email address is permitted each Browns home gameday.
- d. Entrants must be 21 years or older as of date of entry to participate.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 years of age or older at time of entry and who reside in the state of Ohio. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state, and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. Five (5) prizes will be awarded in this Promotion. Each prize consists of the following:
 - One (1) Jack Daniel's rolling cooler
 - Four (4) Jack Daniel's Bandanas
 - Two (2) Jack Daniel's Bottle Openers

- Two (2) Jack Daniel's Football Jerseys

The Approximate Retail Value ("ARV") of the prize is \$300. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- b. All prizes must be picked up at the office of GKB at the address below. The winner will forfeit any prize or prize certificate not claimed within forty-five (45) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- c. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. The winners of the Promotion will be randomly selected and notified by an ESPN Cleveland representative between the hours of 9AM and 5PM EST on the next business day after every Browns' weekend home game. Only one winner will be selected after each game. The dates of selection will be as follows: 1) Monday, October 10, 2022, 2) Monday October 17, 2022, 3) Monday, November 28, 2022, 4) Monday, December 19, 2022 (2 selections will be made for this game).

Note: All entries received each game will expire once a winner has been selected. Fans will be allotted re-entry if they do not win the week they enter and re-visit the ESPN Cleveland Street Team on the next Browns' weekend home game until the end of the Promotion.

- c. The final two (2) winners will be randomly selected and notified by an ESPN Cleveland representative on Monday, December 19, 2022, between the hours of 9AM and 5PM EST.
- d. Odds of winning one of the prizes depends upon the number of entries received each Browns home gameday, the ability to meet eligibility requirements, and random selection.
- e. Winners need not listen to ESPN Cleveland to win. Winners need not be present to win.

- f. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited, and an alternate winner may be randomly selected. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by GKB in a calendar year with an aggregate value of \$600 or more. - b. By participating in the Promotion, the winner agrees to have the winner's name, voice and likeness used in any advertising or broadcasting material relating to the Promotion without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.

Prior to awarding any prize(s) or prize certificate(s), GKB, in its sole discretion, may require Promotion winner(s) (and any travel companion(s) or guest(s)) to sign a liability release, agreeing to release and hold harmless GKB, its subsidiary and affiliated entities, their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns from and against any and all claims or liability arising directly or indirectly from the prize and participation in the Promotion.
- d. If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with

the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.

- f. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of GKB, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, GKB reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Promotion and shall not be required to award a substitute prize.
- g. GKB is not responsible for typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize.
