

Joebees ESPN Cleveland Vegas Trip Giveaway

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. HOW TO ENTER

- a. These rules govern the Joebees ESPN Cleveland Vegas Trip Giveaway promotion (the "Promotion") being conducted by ESPN Cleveland, 1301 E 9th St, Suite 252, Cleveland OH 44114 ("GKB") beginning on Thursday, March 14th at 9am ET and ending on Friday, March 29th at 6pm ET. The qualifying period ends on Sunday, March 17th at 11:59pm ET.
- b. To participate in the Promotion, you may enter via the following method(s):
 - i. Log onto ESPNClevelandContests.com and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth and a valid email address in the online entry form. Thirty (30) entrants will be randomly selected from all submissions to spin a roulette wheel in the ESPN Cleveland studio, during either The Really Big Show or during The Next Level. Qualifiers will be selected on Monday, March 18th at 9am and assigned a time slot to come into the studio and participate, must be present. The Really Big Show will have contestants spin the roulette wheel every day during the promotion at 10:45am ET and 12:30pm ET. The Next Level will have contestants spin the roulette wheel every day during the promotion at 3:45pm ET and 5:30pm ET. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each entrant must agree to GKB's online submission release in order to submit his or her entry.
 - ii. Entrants may also visit Twitter.com and tweet "#JoebeesVegas" to @ESPNCleveland. If you do not already "follow" @ESPNCleveland, then you

must “follow” the Page in order to qualify for the Promotion. You must have a valid Twitter account in order to enter. If you do not already have one, you can create a Twitter account at no cost by visiting <http://www.twitter.com>. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by GKB. Internet entrants are subject to all notices posted online including but not limited to GKB’s Privacy Policy. Use of Twitter as a means of entry will be subject to Facebook’s privacy policy and terms of service. By participating in the Promotion, entrant understands that he or she is providing his or her information to GKB and not Twitter. Further, entrant specifically agrees to release Facebook from any and all liability associated with this Promotion. The Promotion is in no way sponsored, endorsed or administered by, or associated with, Twitter. Eight (8) entrants will be randomly selected from all Twitter submissions to spin a roulette wheel in the ESPN Cleveland studio, during either The Really Big Show or during The Next Level. Qualifiers will be selected on Monday, March 18th at 9am and assigned a time slot to come into the studio and participate, must be present. The first two qualifiers who are in studio during their assigned times that spin a 6 on the roulette wheel will win the grand prizes.

- c. No limit on entries via Twitter.
- d. Participants may enter both online at ESPNClevelandcontests.com and through twitter.
- e. Participants cannot qualify to spin twice.
- f. 8 qualifiers will be selected via Twitter submissions.
- g. 30 qualifiers will be selected via the online entry form found at espnlevelandcontests.com.
- h. Qualifiers from the online contest will be notified via email on Monday, March 18th at approximately 9am.
- i. Qualifiers from Twitter will be notified via direct message on Monday, March 18th at approximately 9am.
- j. If qualified, participants will be assigned a time between Tuesday March 19th and Thursday March 28th to either spin the roulette wheel during the Really Big Show at 10:45a or 12:30p, or on the Next Level at 3:45p or 5:45p, or on March 29th during the Really Big Show at 9:15am, 10:45am, or 12:30pm or during The Next Level at 3:00pm, 3:45pm, and 5:30pm.
- k. If a qualifier cannot make their assigned time, they are exempt from the contest, no exceptions, and an alternate qualifier will be selected.
- l. Times slots cannot be traded between qualifiers.
- m. No substitution or proxy may spin in your place. Only qualifiers with proven identification will be able to spin. No exceptions.
- n. Should a qualifier not show up to their allotted time slot, they will be disqualified and an alternate will not be selected.
- o. Qualifiers must give 24 hours’ notice of a cancellation in order for their spot to be filled with a replacement qualifier.

p. In the event that a prize is not won through the roulette wheel, a winner will be randomly selected from all 38 qualifiers who spun the wheel in person via a random number generator.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 and over. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, [other radio stations in the Cleveland metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every thirty (30) days and only once every six (6) months if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. Two prizes will be awarded in this Promotion. Each prize consists of the following:
A roundtrip flight for two to Las Vegas, Nevada, two nights hotel stay at MGM Grand Las Vegas, dinner and drinks for two at Mabel's BBQ Las Vegas, and inclusion for two in the Joebees ESPN Cleveland poker tournament.

Airfare for two people to Las Vegas, Nevada from the winners nearest airport arriving on April 13th, 2019 and departing April 15th, 2019. The Prize also includes two nights hotel stay at MGM Grand Las Vegas, dinner and drinks for two at Mabel's BBQ Las Vegas, and buy in to the Joebees ESPN Cleveland poker tournament. The Approximate Retail Value ("ARV") of the prize is \$2000. Certain travel restrictions may apply. Travel arrangements must be made through GKB. Prize is subject to availability. If the winner cannot travel on dates specified by GKB, the winner may be disqualified and an alternate winner may be selected in GKB's sole discretion. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and ground transportation to/from the airport and/or to/from the hotel, are the responsibility of the winner.

The winner and travel companion(s) must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. If applicable, the winner may be required to present a valid credit card upon hotel check in to cover any incidental expenses incurred during the winner's stay. The winner and travel companion(s) must sign a Publicity, Liability Waiver and Travel Release form prior to traveling. If a selected event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, or for any reason beyond the control of the Station, the Station's sole responsibility to the winner will be to award the remaining available portion of the prize and no substitution or compensation will be provided for the unawarded portion of the prize. GKB reserves the right to remove or to deny entry to the winner and/or travel companion(s) if either engages in a disruptive manner or with intent to annoy, abuse, threaten or harass any other person at the Joebees ESPN Cleveland Poker Tournament.

- b. All prizes will be coordinated by an ESPN Cleveland teammate prior to the Joebees ESPN Cleveland Vegas Trip. The winner will forfeit any prize or prize certificate not claimed within two (2) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- b. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. The first two qualifiers to land on a 6 will win the contest. If at no point during the promotion dates anyone lands on a 6, the prize(s) will be awarded from the 38 qualifiers who spun the roulette wheel in person to two (2) randomly selected entrants via random number generator.
- c. Winners will be determined by Friday, March 29th at 6pm ET.
- d. Odds of becoming a qualifier depend on the number of submissions both on Twitter and online at ESPNClevelandContests.com.
- e. Odds of winning the prize if selected to participate are 1/38.

- f. Qualifiers need not listen to ESPN Cleveland to win. Qualifiers and the prize winner must be present to win if through the roulette wheel. Qualifier does not need to be present to win if selected by random
- g. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within two (2) days of winning or prize will be forfeited, and an alternate winner may be selected by random selection from all entries. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by GKB in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.
- b. By participating in the Promotion, the winner agrees to have the winner's name, voice and likeness used in any advertising or broadcasting material relating to the Promotion without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.
- c. Prior to awarding any prize(s) or prize certificate(s), GKB, in its sole discretion, may require Promotion winner(s) (and any travel companion(s) or guest(s)) to sign a liability release, agreeing to release and hold harmless GKB, its subsidiary and affiliated entities, their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns from and against any and all claims or liability arising directly or indirectly from the prize and participation in the Promotion.
- d. If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect

entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).

- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of GKB, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, GKB reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Promotion and shall not be required to award a substitute prize.
- g. GKB is not responsible for typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize.
- h.
