

KBN X PALERMO'S MEN'S BASKETBALL CONTEST

OFFICIAL RULES

1. HOW TO ENTER

- a. - b. To participate in the Promotion, you may enter via the following method(s):
 - i. To participate in the Promotion, you must listen to 94.5 ESPN Milwaukee each day beginning and ending on Monday, March 16, 2026, between the hours of 2:00 PM CST and 5:00 PM CST on the promotion date for the announcement of the cue to call. Upon hearing the cue to call, the designated number caller (as announced by the on-air personality prior to the cue to call) to get through to the GKB contest line at (800)-990-3776 will win a qualifying prize upon confirmation of eligibility. At the time of their call, callers will be required to provide all information requested including their full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. In the event that the selected caller is disconnected or is found to be ineligible, the next eligible caller that successfully makes it through on the call-in line and completes their call will be a winner. - b. Four (4) qualifying winners will be selected on Monday, March 16, 2026, between 2:00 PM CST and 5:00 PM CST on 94.5 ESPN Milwaukee during *Kyle, Brust & Nortman* by cue to call. Listeners who call the designated contest phone number when prompted on-air and are the specified caller, as determined by Good Karma Brands, will be declared qualifying winners.
- c. One (1) grand prize winner will be determined on Sunday, April 6, 2026, following the conclusion of the Men's Division I College Basketball Tournament Championship game. The qualifying contestant associated with the region whose team wins the championship game will be declared the grand prize winner and will receive the grand prize. All qualifying contestants will also receive one (1) "Screamin' Sicilian Pizza" Winner hat.
- d. Odds of winning a Qualifying Prize depend upon the number and order of calls received.

Upon selection, each contestant will be randomly assigned to represent one (1) region of the Men's Division I College Basketball Tournament. The contestant assigned to the region whose team ultimately wins the tournament championship will be declared the grand prize winner.
