

Kollege Town Sports Name That Athlete

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. HOW TO ENTER

- a. These rules govern the “Kollege Town Sports Name That Athlete” promotion (the “Promotion”) being conducted by ESPN Madison, 15 N Pinckney St. Suite 100, Madison, WI 53703 (“GKB”) beginning on Wednesday, April 19, 2017 at 10 AM CST and ending on Friday, March 30, 2018 at 5 PM CST.
- b. To participate in the Promotion, you may enter via the following method:
 - i. To participate in the Promotion, you may visit www.Twitter.com/ESPNMadison (“Page”). If you do not already “Follow” the account, then you must “Follow” the account in order to access the Promotion. Look for the Kollege Town Sports “Name That Athlete” clue cards that will be posted every Wednesday, Thursday and Friday and reply with your guess of who the athlete is. There will be one clue posted every Wednesday, Thursday and Friday, totaling three (3) clues for each week’s contest. You can reply to any of the clue cards with your guess, but you must reply with the correct athlete to be entered to win. You must have a valid Twitter account in order to enter and your Tweet Privacy must be set to un-protected. If you do not already have one, you can create a Twitter account at no cost by visiting <http://www.twitter.com>. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by GKB. Internet entrants are subject to all notices posted online including but not limited to GKB’s Privacy Policy. Use of Twitter as a means of entry will be subject to Twitter’s privacy policy and terms of service. By participating in the Promotion, entrant understands that he or she is providing his or her information to GKB and not Twitter. Further, entrant specifically agrees to release Twitter from any and all liability associated with this Promotion. The Promotion is in no way sponsored, endorsed or administered by, or associated with, Twitter.
- c. No limitation on number of entries per person per week. Entries are only accepted via Twitter submissions. All entries must be submitted by 5 PM CST every Friday to be considered for that week’s contest.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 and who reside in the Madison DMA and Milwaukee DMA. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, [other radio stations in the Madison metropolitan area] and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every thirty (30) days and only once every six (6) months if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and execute and return the affidavit of eligibility and liability/publicity release to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. 1 prize will be awarded every Friday for the duration of this Promotion. Each prize consists of the following:

Wisconsin Badgers licensed items from Kollege Town and FanaKTive. The Approximate Retail Value ("ARV") of the prize is \$100.00. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.
- b. All prizes or prize certificates may be picked up at the office of GKB at the address below. If winner resides in the Milwaukee DMA they can choose to pick up the prize at the office of ESPN Milwaukee at 310 West Wisconsin Avenue, Suite 100, Milwaukee, WI 53203. The winner will forfeit any prize or prize certificate not claimed within forty-five (45) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore,

winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.

- b. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. One winner will be randomly selected every week from all correct entries submitted via Twitter. Winner will be selected by 5 PM CST every Friday.
- c. One winner will be selected every Friday by 5 PM CST until the promotion ends on Friday, March 30, 2018.
- d. Winner does not need to be present to win or listen to 100.5 ESPN. Winner must "Follow" ESPN Madison on Twitter (www.Twitter.com/ESPNMadison).
- e. The winner will be announced every Friday around 5 PM CST via Twitter with their name tweeted by @ESPNMadison when the correct athlete is posted. The winner will be contacted via Direct Message or a reply from the ESPN Madison account on Twitter. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by GKB in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.

relating to the Promotion without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.

If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of GKB, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, GKB reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Promotion and shall not be required to award a substitute prize.
