

## LUNCH WITH SILVY SWEEPSTAKES

### OFFICIAL RULES

***NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.***

#### 1. HOW TO ENTER

- a. These rules govern the Lunch with Silvy Sweepstakes promotion (the “Sweepstakes”) being conducted by Good Karma Broadcasting, LLC dba ESPN Chicago, 190 N State St Suite 700, Chicago, IL 60601 (“GKB”) beginning on Tuesday, November 5, 2024 at 12:01am central time (“CT”) and ending on Monday, November 25, 2024 at 11:59pm CT (“Sweepstakes Period”).
- b. To participate in the Sweepstakes, you may enter via the following method: Going to [www.espnchicagocontests.com](http://www.espnchicagocontests.com) and complete the online entry form during the Sweepstakes Period and confirm eligibility requirements.

To participate in the Sweepstakes, you must go to [www.espnchicagocontests.com](http://www.espnchicagocontests.com), and follow the links and instructions to enter the Sweepstakes and submit your first and last name and date of birth as well as their first and last name, date of birth, telephone number, a valid email address for your chance to win lunch with Silvy courtesy of Chicagoland Toyota Dealers. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB’s computer is the official time keeping device for the Sweepstakes. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each entrant must agree to GKB’s online submission release in order to submit his or her entry.

- c. You may have a maximum of one (1) win per Sweepstakes Period. Prizes can only be won by being the designated number caller on Sweepstakes Dates.

## 2. ELIGIBILITY RESTRICTIONS

- a. The Sweepstakes is open to all persons who are 18 years of age or older as of Tuesday, November 5, 2024 and who reside in the following counties: Cook County, IL, Dekalb County, IL, DuPage County, IL, Kane County, IL, Kankakee County, IL, Kendall County, IL, Kenosha County, WI, Lake County, IL, LaPorte County, IN, McHenry County, IL, Porter County, IN, and Will County, IL. Employees of GKB, the Chicago Region Toyota Dealers Association, Inc. ("TDA"), Toyota Motor Sales USA Inc. ("TMS"), and each of their subsidiary and affiliated entities, advertising and promotional agencies, any participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Sweepstakes is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Up to one (1) win per person per Sweepstakes Period. Entrants are eligible to win a prize in only one (1) sweepstakes or promotion conducted by GKB, including this Sweepstakes, once every seven (7) days and once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB sweepstakes.
- c. Entrants are required to provide truthful information. GKB will reject and delete any entry that it determines, in its sole and absolute discretion, to be false or fraudulent. GKB will disqualify any Entry from individuals who do not meet the eligibility requirements.

## 3. PRIZES

- a. Up to one (1) prize will be given away. Each prize will include:

One (1) lunch with Marc Silverman of ESPN 1000 Chicago during November or December 2024. The Approximate Retail Value ("ARV") of the prize is \$100. Prize is subject to availability. Each winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB and TDA accept no responsibility for any liability arising out of each winner's acceptance or use of the Prize and/or any entrants participation in the Sweepstakes. If a selected event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, or for any reason beyond the control of GKB, GKB's sole responsibility to the winner will be to award the remaining available portion of the prize and no substitution or compensation will be provided for the unawarded portion of the prize. The prize will be subject to the terms and conditions as set forth by the issuer of the prize.

- b. Prize fulfillment will be handled via email. The winners will forfeit any prize or prize certificate not claimed within five (5) days of winning. In the event that a

prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.

- c. There is no substitution, transfer or cash equivalent for prizes, except that TDA or GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

#### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Sweepstakes are final.
- b. One (1) grand prize winner will be randomly selected by 5pm CT on Tuesday, November 26, 2024.
- c. The odds of winning the grand prize depends on the number of valid entries received.
- d. Prize winners do not need to be present to win.
- e. The winner shall be required to (a) execute and notarize an affidavit of eligibility and liability/publicity release within five (5) days of winning or prize will be forfeited. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize and an alternative winner shall be selected.

#### 5. CONDITIONS

- a. consent of, to the winner to the extent permitted by law and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.

- c. Prior to awarding any prize(s) or prize certificate(s), GKB, in its sole discretion, may require Sweepstakes winner(s) (and any travel companion(s) or guest(s)) to sign a liability release, agreeing to release and hold harmless GKB, TDA, TMS, and each of their subsidiary and affiliated entities, their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns from and against any and all claims or liability arising directly or indirectly, including but not limited to, any property loss, damage, personal injury, or death from the prize and participation in the Sweepstakes.
- d. If for any reason this Sweepstakes cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Sweepstakes, or if the Sweepstakes is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Sweepstakes. If the Sweepstakes is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Sweepstakes may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Sweepstakes, GKB reserves the right to disqualify that entrant from entering and/or winning future Sweepstakes or Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f. GKB reserves the right to make changes in the rules of the Sweepstakes, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of GKB, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, GKB reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Sweepstakes and shall not be required to award a substitute prize.
