

MKE Black Summer Marketplace Register to Win

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

ON SATURDAY, JULY 24, 2021, 101.7 THE TRUTH WILL BE ON-SITE WITH A STREET TEAM AT THE SECOND MKE BLACK SUMMER MARKETPLACE FROM 11A CST – 3P CST. DURING THAT TIME, FANS CAN VISIT THE 101.7 THE TRUTH BOOTH ON-SITE TO SCAN A QR CODE TO FILL OUT A REGISTER TO WIN FORM ONLINE FOR A CHANCE TO WIN A PRIZE. THE PRIZE INCLUDES (10) TICKETS TO THE 2021 WISCONSIN STATE FAIR, (4) TICKETS TO THE MILWAUKEE COUNTY ZOO, AND \$50 IN COUSINS SUBS GIFT CARDS. THE TOTAL PRIZE IS VALUED AT AN ESTIMATE TOTAL OF \$200.00. THE WISCONSIN STATE FAIR TICKETS EXPIRE ON SUNDAY, AUGUST 15, 2021 FOLLOWING THE CONCLUSION OF THE 2021 WISCONSIN STATE FAIR. THE MILWAUKEE COUNTY ZOO TICKETS EXPIRE ON DECEMBER 31, 2021. ONE RANDOM WINNER WILL BE CHOSEN FROM THE ELIGIBLE FORM ENTRIES. THE WINNER WILL BE CONTACTED BY THE TRUTH MARKETING DEPARTMENT ON MONDAY, JULY 26, 2021.

1. HOW TO ENTER

- a. These rules govern the MKE Black Summer Marketplace Register to Win promotion (the “Promotion”) being conducted by WGKB 101.7 The Truth 720 E. Capitol Drive Milwaukee, WI 53212 (“GKB”) beginning on Saturday, July 24, 2021 at 11:00a CST and ending on Saturday, July 24, 2021 at 3:00p CST.

- b. To participate in the Promotion, you may enter via the following method(s):

Fans may visit the 101.7 The Truth booth on-site at the Beerline Plaza on 3356 N. Holton St. Milwaukee, WI 53212 between 11a – 3p CST to scan a QR code to complete an online register to win form.

- i. To participate in the Promotion, you may visit the 101.7 The Truth booth on-site at the MKE Black Summer Marketplace at the Beerline Plaza in Milwaukee and scan the virtual QR code on-site to access an online register to win form. Once you have access to the online register to win form, follow instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address.

Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each entrant must agree to GKB's online submission release in order to submit his or her entry.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 and who reside in the Greater Milwaukee Area. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, [other radio stations in the Milwaukee metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

 - o Tickets expire following the conclusion of the fair on August 15, 2021
 - (4) tickets to the Milwaukee County Zoo
 - o Tickets expire on December 31, 2021
 - \$50 to Cousins Subs

The Approximate Retail Value ("ARV") of the prize is \$200. The winner will be solely responsible for all taxes and all other fees and expenses not specified

herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize. The gift certificates/tickets will be subject to the terms and conditions as set forth by the issuer of the gift certificate/tickets.

- b. All prizes or prize certificates will be mailed from the office of GKB at the address below. To claim the prize, the winner must have submitted all required prize forms to GKB. The winner will forfeit any prize or prize certificate not claimed by Wednesday, July 28, 2021 at 5pm CT. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.

- b. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.

- b. There will be a total of (1) grand prize winner during the promotion dates. A winner will be selected on Monday, July 26, 2021. GKB's promotions team will contact the grand prize winner by the end of the day on Monday, July 26, 2021 at 5:00pm CST.

- c. The final winner will be determined by Monday, July 26, 2021 at 5pm CST.

- d. Odds of winning the grand prize depends upon the number of entries received, eligibility requirements, and random selection.

- e. Qualifiers must not listen to WGKB to win. Qualifiers and the Grand Prize winner need not be present to win.

- f. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release by Wednesday, July 28, 2021 at 5pm CT or prize will be forfeited. All forms must be completed in full and returned to GKB with all required information before prize is mailed. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize. No new winner will be chosen.

- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes.
