

Miami Marlins Ticket Giveaway

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. HOW TO ENTER

- a. These rules govern the Miami Marlins Ticket Giveaway promotion being conducted by ESPN West Palm, 777 South Flagler Drive, Suite 106 West Palm Beach, FL 33401 ("GKB") beginning on Wednesday, May 4th, 200 at 12 PM ET and ending on Saturday, May 14th, 2022 at 6 PM ET.
- b. To participate in the Promotion, you may enter via the following method(s): Call into Ken LaVicka Live, be the 8th caller, and get to play Fish, Fish, or Phish. Where the caller gets to choose whether they want to answer a question about the Marlins, the aquatic animal, or the band Phish. Correct answer wins a pair of tickets.

Attend the Derby Party at ER Bradley's and Enter the Raffle. Winner must be present to win.

Comment MARLINS on the Facebook post on ESPN West Palm's Facebook account.

- i. To participate in the Promotion, you must listen to WUUB 106.3 FM each day beginning on Wednesday, May 4th, 2022 and ending on Friday, May between the hours of 12 PM ET and 2 PM ET each day for the announcement of the cue to call, and play the game, Fish (the Marlins), Fish (the aquatic animal), or Phish (the band.) Upon hearing the cue to call, the 8th designated number caller to get through to the GKB contest line at 888-760-3776 will get to play to win 2x tickets to the Miami Marlins vs. Milwaukee Brewers on Saturday, May 14th game upon confirmation of eligibility. At the time of their call, callers will be required to provide all information requested including their full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. In the event that the selected caller is disconnected or is found to be ineligible, the next eligible caller that successfully makes it through on the call-in line and completes their call will be a winner. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once. There will be up to a total of 2 selected on-air during the Promotion dates. GKB is not responsible for telephone service outages, delays, busy signals, equipment

malfunctions or any other technological difficulties that may prevent an individual from completing his/her telephone call. Due to delays in the GKB online streaming of its broadcast signal, listeners to the online stream may not be able to participate in or may be disadvantaged in participating in on-air contests.

Bradley's on Saturday, May 7th, 2022 starting at 4PM ET and ending at 6 PM ET and complete an official entry form (while supplies last) including first and last name, complete address, city, state, zip code, home telephone number and date of birth, and put the entry form in the registration box. All entries must be received by 6 PM ET GKB is not responsible for lost, stolen, mangled, misdirected, , incomplete or late entries.
- iii. To participate in the Promotion, you may visit www.Facebook.com/espnwestpalm. Follow the links and instructions to complete, and comment "MARLINS" during the Entry Period. You must have a valid Facebook account in order to enter. If you do not already have one, you can create a Facebook account at no cost by visiting <http://www.facebook.com>. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by GKB. Internet entrants are subject to all notices posted online including but not limited to GKB's Privacy Policy. Use of Facebook as a means of entry will be subject to Facebook's privacy policy and terms of service. By participating in the Promotion, entrant understands that he or she is providing his or her information to GKB and not Facebook. Further, entrant specifically agrees to release Facebook from any and all liability associated with this Promotion. The Promotion is in no way sponsored, endorsed or administered by, or associated with, Facebook.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 and who reside in Palm Beach County and the Treasure Coast. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize

is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.

- c. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. 4 prizes will be awarded in this Promotion. Each prize consists of the following:
A pair of tickets to the Miami Marlins Game against the Milwaukee Brewers on Saturday, May 14th at 6:10.

The Approximate Retail Value ("ARV") of the prize is \$50. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- b. All prizes will be emailed to the winner. The winner will forfeit any prize or prize certificate not claimed before Friday, May 13th at 5PM ET.
- b. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. Winners of on-air giveaway will be notified immediately following the question and answer. Facebook winners will be notified via Direct Message on Tuesday, May 10th at 9 AM. On-site winner will be notified at the event at 6 PM on Saturday, May 7th, 2022.
- c. Odds of winning a Qualifying Prize depends upon the number and order of calls received. Odds of a Qualifier winning the Grand Prize are 1 in 15.
- d. Qualifiers must listen to WUUB 106.3 to win on air tickets. Winners of On-Site Raffle must be present to win.

- e. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited, and an alternate winner may be selected. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS
