

# MICHELOB ULTRA & VELOSANO TREK BIKE GIVEAWAY 2022

## OFFICIAL RULES

The contest will begin on Friday, July 8, 2022, at 12AM EST and will end on Sunday, September 4, 2022, at 11:59PM EST. Twenty-six (26) lucky fans will be randomly selected as winners of the contest. ### 1. HOW TO ENTER

- a. These rules govern the Michelob Ultra & Velosano Trek Bike Giveaway 2022 contest (the "Promotion") being conducted by ESPN Cleveland, 1301 E. 9<sup>th</sup> Street Suite 252, Cleveland, OH 44114 ("GKB") beginning on Friday, July 8, 2022, at 12AM EST and ending on Sunday, September 4, 2022, at 11:59PM EST.
- b. To participate in the Promotion, you may enter via the following method(s):
  - Locate a Michelob Ultra/Velosano QR code at participating Giant Eagle locations in the Cleveland area to scan with a mobile device and follow the instructions to enter the promotion.
  - Complete the online register to win form at [www.ESPNclevelandContests.com](http://www.ESPNclevelandContests.com).
- i. To participate in the Promotion, you may scan the QR code at participating Giant Eagle Northeast Ohio locations or log onto [www.ESPNclevelandContests.com](http://www.ESPNclevelandContests.com) and follow the links and instructions to enter the Promotion. You may be asked to submit your first and last name, complete address, city, state, zip code, telephone number, date of birth, and a valid email address in the online entry form. All potential winners are subject to verification and must meet the eligibility requirements as outlined in these contest rules before any prize will be awarded. There will be twenty-six (26) total Grand Prize winners as a result of this Promotion.
- ii. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for

assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. ## 2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 years of age or older and who reside in the state of Ohio. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state, and local laws and regulations and is void where prohibited.

- A Trek 820 Cross Country Mtn Bike (Trek Custom Steel Frame, Bontrager LT3 26x2.00" Tires, Tektro Alloy Linear-Pull Brakes, Shimano TZ500, 14-28, 7 Speed Cassette, Shimano Tourney EF41 Shifters)

The Approximate Retail Value ("ARV") of the prize is \$545. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- b. All prizes must be picked up at the office of GKB at the address below. The winner will forfeit any prize or prize certificate not claimed within forty-five (45) days of winning. GKB is not responsible for the safe arrival of a prize or prize certificate.

- b. Winners will be randomly selected and notified by phone the week of Monday, September 5, 2022, through Friday, September 9, 2022 between the hours of 9AM EST and 7PM EST.
- c. The final winner will be selected and notified on or before Friday, September 9, 2022 between 9AM EST and 7PM EST.
- d. Odds of winning a prize depends on the number of entries received.
- e. Winners need not listen to 850 ESPN Cleveland to win. Winners need not be present at drawing to win.
- f. The winners must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited, and alternate winners may be randomly selected.
