

# MILLER LITE® TICKET SWEEPSTAKES

## OFFICIAL RULES

***NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.***

### 1. HOW TO ENTER

- a. These rules govern the Miller Lite Ticket Sweepstakes (the “Sweepstakes”) being conducted by Good Karma Broadcasting, LLC dba ESPN Chicago, 190 N State St Suite 700, Chicago, IL 60601 (“GKB”) beginning on Friday, October 25, 2024 at 2:30pm central time (“CT”) and ending on Wednesday, November 27, 2024 at 6:30pm CT (“Sweepstakes Period”).

Wednesday, November 27, 2:30p-6:30p CT: Crazy Pour at 105 E North Ave, Villa Park, IL 60181; (each a “Sweepstakes Date” and collectively referred to as “Sweepstakes Dates”); and,

- ii. visit the ESPN Chicago street team and get a raffle ticket.

- c. You may have a maximum of one (1) entry per Sweepstakes Date. Entries can be made in-person only at Locations on Sweepstakes Dates.

### 2. ELIGIBILITY RESTRICTIONS

- a. The Sweepstakes is open to all persons who are 21 years old or older as of Friday, October 25, 2024, and who reside in the United States of America, excluding residents of Rhode Island. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, Molson Coors Beverage Company, The Chicago Bears Football Club, Inc. ("Chicago Bears") its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. - j. There is no substitution, transfer, or cash equivalent for the Prizes, except that GKB may, at its sole discretion, substitute Prizes for cash of comparable value. The Prizes are expressly limited to the item(s) listed above and, unless otherwise expressly specified, do not include taxes, gratuities or any other expenses including travel, lodging, or food. #### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Sweepstakes are final.
- b. Prize Winners will be randomly selected by 5pm CT the next business day after each Sweepstakes Date, provided that there is an eligible Entrant for each Sweepstakes Date.
- c. Odds of winning a Prize are dependent on total number of Entries each Sweepstakes Date.
- d. Prize Winners must be present at the time of the random drawing to win.
- e. Each Prize Winner must execute and return any required affidavit of eligibility and/or liability/publicity release within five (5) days of winning or Prize will be forfeited. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a Prize or Prize notification is returned as undeliverable, the potential winner forfeits the Prize. - g. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Sweepstakes may result in a contestant's disqualification and/or forfeiture of any Prize or Prizes. If GKB makes a good faith determination that an Entrant has cheated or committed fraudulent activity in connection with a Sweepstakes, GKB reserves the right to disqualify that Entrant from entering and/or winning future Sweepstakes and to prosecute and seek damages to the fullest extent permitted by law.
