

MILLION DOLLAR MONDAYS 2025

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

ESPN Los Angeles and Pechanga Resort Casino are giving away Rams tickets and a chance at winning \$1,000,000 throughout the 2025-2026 pro football season. Fans may enter by being the correct number caller upon hearing the cue to call and providing a prediction for the two participating teams, which team will be the winner, and the final score of the championship game at the end of the 2025-2026 season during ESPN LA shows on Mondays between 10a PT and 7p PT, beginning on Monday, September 15, 2025, and ending on Monday, December 1, 2025. There will be a total of (36) Qualifying Prizes and (1) potential Grand Prize awarded in the contest. The total ARV of each Qualifying Prize is \$126. The total ARV of the Grand Prize, should someone win it, is \$1,000,000.

1. HOW TO ENTER

- a. These rules govern the Million Dollar Mondays 2025 promotion (the "Promotion") being conducted by Good Karma Broadcasting, dba ESPN Los Angeles, 800 W. Olympic Blvd Suite 200, Los Angeles CA 90015 ("GKB") beginning on Monday, September 15, 2025, and ending on Monday, December 1, 2025.
- b. To participate in the Promotion, you may enter via the following method(s):
 - i. To participate in the Promotion, you must listen to KSPN-AM each day beginning on Monday, September 15, 2025, and ending on Monday, December 1, 2025 between the hours of 7a-6p PT each Monday during the Promotion Dates for the announcement of the cue to call. Three cues to call will be executed each Monday during the Promotion Dates. The cues to call may happen during any of the following shows: The Sedano & Kap Morning Show (7a-9a PT), Mason & Ireland (12p-3p PT), The D'Marco & Travis Afternoon Show (3p-6p). The number of cues to call executed in each show may vary based on schedule and there is no guarantee that one will take place in each show on each Monday. Upon hearing the cue to call, the designated number caller (as announced by the on-air personality prior to the cue to call) to get through to the GKB contest line at 877-710-3776(ESPN) will win a Qualifying Prize upon confirmation of eligibility. They will also be awarded the opportunity at that time to make their prediction for the pro football championship game by providing which two teams they think will be participating in the game, which team they think will win the game, and what they think the final score of the game will be. At the time of their call, callers will be required to provide all information requested including their full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. In the event that the selected caller is disconnected or is found to be ineligible, the next eligible caller that successfully makes it through on the call-in line and completes their call will be a winner. There is no limit to the number of times a listener may attempt to

call in to win, but a listener may be a winner only once. There will be up to a total of (36) winners selected on-air during the Promotion dates. GKB is not responsible for telephone service outages, delays, busy signals, equipment malfunctions or any other technological difficulties that may prevent an individual from completing his/her telephone call. Due to delays in the GKB online streaming of its broadcast signal, listeners to the online stream may not be able to participate in or may be disadvantaged in participating in on-air contests. Show times are subject to change based on breaking news and specialty content at the discretion of GKB. GKB has the right to not notify fans and to not update contest rules or the webpage when such conditioners occur.

- c. Limit (1) winner per household for any Qualifying Prize. Only Qualifying Prize winners are eligible to win a Grand Prize.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 or older and who reside in the United States. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. A total of (36) Qualifying Prizes will be awarded in this Promotion. Each Qualifying prize consists of the following:
 - (2) tickets to an LA Rams home game during the 2025-2026 season (game to be determined by GKB with input and recommendation from Qualifying Prize winners)

The Approximate Retail Value ("ARV") of each Qualifying Prize is \$126. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein

associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- b. There is the potential for (1) Grand Prize to be awarded in this Promotion. The Grand Prize consists of the following:
 - \$1,000,000
- a. The Approximate Retail Value (“ARV”) of the Grand Prize is \$1,000,000. Prize amount to be paid fifty (50) equal annual installments of \$20,000 each, without interest. In lieu of annual installment payments, the prize may also be paid in a one-time lump sum payout based on current annuity rates. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.
- c. All prizes or prize certificates may be picked up at the office of GKB at the address below. Qualifying Prize winners will forfeit the prize of tickets if not claimed within seven (7) days of winning. The Grand Prize winner will forfeit the Grand Prize if not claimed within forty-five (45) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- d. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. Qualifying Prizes will be awarded on Mondays during the Promotion Dates. There will be (3) Qualifying Prize winners on each Monday during the Promotion Dates, resulting in (36) Qualifying Prize winners in total.
- c. Each Qualifying Prize winner, at the time they become the correct number caller, will be informed that they have won the Qualifying Prize, and will be prompted to make their championship game prediction: winning team, losing team, and final score. GKB will log all predictions until championship game is played.
- d. After completion of the pro football championship game on Sunday, February 8, 2026, GKB will determine if any Qualifying Prize winners made the correct prediction of winning team, losing team, and final score. If a Qualifying Prize winner indeed provided the exact teams, the winner, and final score for the championship game, that Qualifying Prize winner will be named the Grand Prize winner and will receive the Grand Prize. In

the event that multiple Qualifying Prize winners accurately predict the teams and scores for the game, the Grand Prize shall be awarded by random drawing between the potential Grand Prize Winners.

- e. Odds of winning a Qualifying Prize depends upon the number and order of calls received.
- f. Fans must listen to ESPN Los Angeles in order to win a Qualifying Prize. Qualifying Prize Winners do not then need to listen in order to potentially win a Grand Prize.
- g. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by GKB in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.
- b. By participating in the Promotion, the winner agrees to have the winner's name, voice and likeness used in any advertising or broadcasting material relating to the Promotion without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.
- c. Prior to awarding any prize(s) or prize certificate(s), GKB, in its sole discretion, may require Promotion winner(s) (and any travel companion(s) or guest(s)) to sign a liability release, agreeing to release and hold harmless GKB, its subsidiary and affiliated entities, their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns from and against any and all claims or liability arising directly or indirectly from the prize and participation in the Promotion.
- d. If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible

non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).

- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of GKB, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, GKB reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Promotion and shall not be required to award a substitute prize.
- g. GKB is not responsible for typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize.
- h.
