

TMKS 20th Anniversary Register-To-Win Giveaways

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

ESPN New York is giving away a variety of prizes (all listed below in the Prizes section) at the TMKS 20th Anniversary event on Friday, November 18, 2022. Fans may enter by registering to win in person between 2:00 PM ET and 7:00 PM ET on Friday, November 18, 2022, at the TMKS 20th Anniversary event, located at Palladium Times Square (1515 Broadway, New York, NY 10036). There will be a total of six (6) prizes in the contest. The total ARV of the prize(s) vary based on which prize is won. All prizes and corresponding approximate retail values can be found in the Prizes section below.

1. HOW TO ENTER

- a. These rules govern the TMKS 20th Anniversary Register-To-Win Giveaways promotion (the "Promotion") being conducted by Good Karma Broadcasting, LLC, ESPN New York, 880 3rd Ave, 12th Floor, New York, New York 10022 ("GKB") on Friday, November 18, 2022, beginning at 2:00 PM ET and ending at 7:00 PM ET.
- b. To participate in the Promotion, you may enter via the following method(s):
 - i. To participate in the Promotion, you may go to Palladium Times Square (1515 Broadway, New York, NY 10036) on Friday, November 18, 2022, starting at 2:00 PM ET and ending at 7:00 PM ET and complete an official entry form (while supplies last) including first and last name, complete address, city, state, zip code, home telephone number and date of birth, and put the entry form in the registration box. All entries must be received by 7:00 PM ET. GKB is not responsible for lost, stolen, mangled, misdirected, postage due, illegible, incomplete or late entries.
- c. Only one entry per person per register-to-win box will be eligible. Fans may enter multiple drawings, but may not enter any drawing more than once.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 years of age or older and who reside in the United States of America. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, other radio stations in the New York City metropolitan area (NY, NJ, CT, PA) and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

The Approximate Retail Value (“ARV”) for all prizes are listed immediately above. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize. Any gift card prizes will be subject to the terms and conditions as set forth by the issuer of the gift certificate.

- b. All prizes or prize certificates may either be picked up on site at the end of the event on Friday, November 18, 2022, or may be delivered via mail or email, depending on the prize won. The winner will forfeit any prize or prize certificate not claimed within forty-five (45) days of winning, or the ticket date in the event that the tickets are dated sooner than forty-five (45) days. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. All drawings will be done at 7:00 PM ET on site at the TMKS 20th Anniversary event, at which point entries will be drawn at random.
- c. Odds of winning any of the prizes depend upon the number of entries received.
- d. Entrants must be present to enter. Entrants need not be present to win.
- e. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited and an alternate winner may be selected. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).

- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f.
