

RBS KICKOFF SCAN AND DROP CONTEST

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

850 ESPN Cleveland and FanDuel are giving fans the chance to win a one thousand dollars (\$1,000) cash Grand Prize or one (1) of five (5) Secondary Prizes in the RBS Kickoff Scan and Drop Contest. Fans age 21 and older may attend the RBS Kickoff event at Welcome To The Farm on Friday, September 6, 2024 from 7PM EST until 10PM EST for the chance to qualify. At the on site ESPN Cleveland Marketing table fans may collect (1) promo card with an ESPN Cleveland/FanDuel QR code. Five (5) random and identical cards distributed will have a unique QR code that when scanned, identifies the cardholder to be a Secondary Prize winner. Prize winners may claim their prize by presenting their winning card at the ESPN Cleveland table. Fans holding non-prize winning cards may enter the drawing for the one thousand dollar Grand Prize by writing their first, last name and phone number on the card and dropping it in the collection box at the ESPN Cleveland table no later than 9:00PM EST. Between 9PM and 10:00PM EST, the grand prize winner will be randomly drawn and announced. Winner must be in attendance at time of drawing to win their prize.

HOW TO ENTER

- a. These rules govern the RBS Kickoff Scan and Drop promotion (the "Promotion") being conducted by ESPN Cleveland, 1109 Old River Road, Cleveland, OH 44113 ("GKB") on Friday, September 6, 2024 from 7:00PM EST to 10:00PM EST.
- b. To participate in the Promotion, you may enter via the following method(s):
 - Attend The 2024 RBS Kickoff event to receive a promo card and scan the QR code
- i. To participate in the Promotion, you may attend The RBS Kickoff event at Welcome To The Farm (1054 Old River Road, Cleveland, OH 44113) on Friday, September 6, 2024 starting at 7:00PM EST and ending at 10:00PM EST and locate the ESPN Cleveland Marketing table to receive a Promo card and scan the QR code. If scanning your card shows that you are one of five (5) Secondary Prize Winners, present your card to the ESPN Cleveland table to claim your prize. All non-prize winning cards may be entered in the drawing to win the Grand Prize of one-thousand dollars (\$1,000) cash by clearly writing your first, last name and phone number on your card and dropping it in the collection box. All entries drawing entries must be received before 9:00PM EST and all prizes must be claimed by 10:00PM EST. GKB is not responsible

for lost, stolen, mangled, misdirected, postage due, illegible, incomplete or late entries.

- c. Limit of one card per person will be distributed. Limit one prize per person.
- d. Secondary Prize winners are ineligible to win the Grand Prize.

1. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who 21 years of age or older and who reside in the state of Ohio. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.

- Secondary Prize 2: Cleveland Fan Prize Pack (\$100 Where I'm From gift card, hat, bag)

- Secondary Prize 5: One (1) round of golf for four (4) at StoneWater Golf Club in Highland Heights, Ohio during the 2024 season. (includes green and cart fees).

The Approximate Retail Value ("ARV") of the prize is three hundred and fifty dollars (\$350). The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

b. One (1) Grand Prize will be awarded in the Promotion.

- One thousand dollars (\$1,000) cash

The Approximate Retail Value ("ARV") of the prize is one thousand dollars (\$1,000). The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- c. Prizes or prize certificates may be collected at the event, sent electronically, delivered by mail, or picked up at the office of GKB at the address below. The winner will forfeit any prize or prize certificate not claimed within forty five (45) days of winning. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. Secondary Prize winners will be selected on Friday, September 6, 2024 between 7PM EST and 10PM EST.
- c. The Grand Prize winner will be selected by random drawing and announced between 9PM and 10PM EST on Friday, September 6, 2024. Winner must be present at announcement to win. If the winner is not present to claim their prize within five (5) minutes of the announcement, they will forfeit the prize and an alternate winner will be selected by random drawing.
- d. Odds of winning a Secondary Prize are 1 in 30
- e. Grand Prize depends upon the number of attendees and eligible entries submitted at the event.
- f. Secondary and Grand Prize winners must be present at the event to claim a prize. Prizes not claimed before 10:00PM will be forfeited.
- g. Secondary prize winners must execute and return any required affidavit of eligibility and/or liability/publicity release at the event before 10:00PM or prize will be forfeited. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).

- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f.
