

2017 ESPN Cleveland “Karaoke RBS Open Foursome” Contest

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. HOW TO ENTER

1. These rules govern the “Karaoke RBS Open Foursome” promotion (the “Promotion”) being conducted by ESPN Cleveland & Good Karma Broadcasting (“GKB”) beginning on Monday, June 26, 2017 at 9:00am ET and ending on Tuesday, June 27, 2017 at 1:00pm ET.

To participate in the Promotion, you may enter via the following method(s):

Aaron Goldhammer and Tony Rizzo will pick the first 3 callers during The Really Big Show on Monday, June 26, 2017 to participate in the karaoke sing-off on Tuesday, June 27th in-studio during The Really Big Show.

The 3 contestants picked on The Really Big Show will perform a karaoke song decided by the RBS hosts on Tuesday, June 27, 2017 in-studio.

2. ELIGIBILITY RESTRICTIONS

1. The Promotion is open to all persons who are 18 years and over and who reside in the state of Ohio. Employees of GKB, its subsidiary and affiliated entities, GKB’s advertising and promotional agencies, its participating sponsors, other radio stations in the Cleveland metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

600. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every thirty (30) days and only once every six (6) months if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.

1. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
1. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

One prize will be awarded in this Promotion. The prize consists of the following:

1. A (1) foursome for The 2017 RBS Open on Thursday, June 29th, 2017, donated by Northeast Factory Direct.

The Approximate Retail Value (“ARV”) is \$700 for the total foursome.

1. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

1. Decisions of GKB management with respect to the Promotion are final.

Aaron Goldhammer and Tony Rizzo will pick the first 3 callers during The Really Big Show on Monday, June 26, 2017 to participate in the karaoke sing-off on Tuesday, June 27th in-studio during The Really Big Show.

The 3 contestants picked on The Really Big Show will perform a karaoke song of their choice on Tuesday, June 27, 2017 in-studio. After each of the 3 contestants perform the song of their choice, the panel of 3 judges will determine the winner on-air during The Really Big Show.

1. The winner(s) will be selected on Tuesday, June 27, 2017 at 1:00pm ET.
1. Odds of winning the prize depends upon the vocal talents of each contestant and what the judges score.
1. Winner will be notified in-person on Tuesday, June 27, 2017 by 1:00pm ET to confirm eligibility. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within one (1) day of winning or prize will be forfeited. If winner has not confirmed eligibility by Tuesday, June 27, 2017, at 1:00pm ET, alternate winner(s) will be selected. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

1. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner’s full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by GKB in a calendar year with an aggregate value of

\$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.

By participating in the Promotion, the winner agrees to have the winner's name, voice and likeness used in any advertising or broadcasting material relating to the Promotion without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.

Prior to awarding any prize(s) or prize certificate(s), GKB, in its sole discretion, may require Promotion winner(s) (and any travel companion(s) or guest(s)) to sign a liability release, agreeing to release and hold harmless GKB, its subsidiary and affiliated entities, their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns from and against any and all claims or liability arising directly or indirectly from the prize and participation in the Promotion.

If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
1. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
1. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of GKB, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, GKB reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Promotion and shall not be required to award a substitute prize.
1. GKB is not responsible for typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize.
