

## RBS SUMMER FRIDAY SEPTEMBER 2023

### OFFICIAL RULES

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.**

850 ESPN Cleveland and Northfield Fireplace and Grille are giving fans the chance to win a spot for them and a guest to the second ESPN Cleveland “RBS Summer Friday” event of the year from 12PM to 2PM ET on Friday, September 15, 2023. Fans may enter the contest by filling out the online entry form at [www.ESPNClevelandContests.com](http://www.ESPNClevelandContests.com). Up to ten (10) fans will be randomly selected to attend the event with a guest (the qualifying prize). The prize also includes free food and drink for each person. During the event, attendees will be able to view the final hour of *The Really Big Show* (RBS) broadcast live from the ESPN Cleveland patio in the Flats and interact with the show personalities after the show ends. The entry period will run from Friday, September 1, 2023, at approximately 12:30PM ET through 11:59PM ET on Saturday, Sept 9, 2023. The Actual Retail Value (ARV) of the Grand Prize is \$500. Must be 21 years of age or older to enter. At the beginning of the entry period, the hosts of RBS will announce the start of the contest, which will be the cue for people to go to the contest page on [www.ESPNClevelandContests.com](http://www.ESPNClevelandContests.com) to enter and to also try to be one of the first five (5) entrants. The first five (5) entrants will win the secondary Grand Prize, which is a \$50 gift card to Northfield Fireplace and Grille. **NOTE:** Being among the first five (5) entrants does not guarantee a secondary Grand Prize winner of winning a spot at the “RBS Summer Friday” event, but secondary Grand Prize winners will still be a part of the random selection pool for the Grand Prize.

#### 1. HOW TO ENTER

- a. These rules govern the RBS Summer Friday September 2023 contest (the “Promotion”) being conducted by ESPN Cleveland, 1109 Old River Road, Cleveland, OH 44113 (“GKB”) beginning on Friday, September 1, 2023, at approximately 12:30PM ET and ending on Saturday, September 9, 2023, at 11:59PM ET. The announcement that cues the process for trying to win a secondary Grand Prize will be given on Friday, September 1, 2023, at approximately 12:30PM ET.
- b. To participate in the Promotion for the Grand Prize, you may enter via the following method(s): Fill out the online entry form on [www.ESPNClevelandContests.com](http://www.ESPNClevelandContests.com).
  - i. To participate in the Promotion, you may log onto [www.ESPNClevelandContests.com](http://www.ESPNClevelandContests.com) and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by

the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. To participate in the Promotion for the secondary Grand Prize, you may enter via the following method(s): Wait for the announcement on RBS that the contest is open and fill out the online entry form on [www.ESPNClevelandContests.com](http://www.ESPNClevelandContests.com) to try to be among the first five (5) entrants.
  - i. To participate in the Promotion, you must listen to RBS on Friday, September 1, 2023, for the announcement that this Promotion is open and you may log onto [www.ESPNClevelandContests.com](http://www.ESPNClevelandContests.com) and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth and a valid email address in the online entry form to try to be among the first five (5) entrants. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. ## 2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 years of age or older at time of entry and who reside in the state of Ohio. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, other radio stations in the greater Cleveland metropolitan area, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Entrants must be available to attend the ESPN Cleveland "RBS Summer Friday" event on Friday, September 15, 2023, between the hours of 12PM and 2PM ET.
- c. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- d. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- e. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

## 3. PRIZES

- a. Ten (10) Grand Prizes will be awarded in this Promotion. Each prize consists of the following:
  - Two (2) passes for entry to the RBS Summer Friday event on Friday, September 15, 2023, for each randomly selected winner and a guest of their choice. The event will take place on the ESPN Cleveland office patio, located at 1109 Old River Road, Cleveland, OH 44113.
  - One (1) free meal prepared by a Northfield Fireplace designated chef and two (2) free drinks (alcoholic and/or non-alcoholic) for the winner and their guest.
  - One (1) Northfield Fireplace Swag Bag.

The Approximate Retail Value ("ARV") of the prize is \$500. The winner will be solely responsible for all taxes and all other fees and expenses not specified

herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

The winner will forfeit any prize or prize certificate not claimed within two (2) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.

**Note:** Fans must wait until the cue to head to the contest page is given by the hosts of *The Really Big Show* on Friday, September 1, 2023, to enter. Winning a secondary Grand Prize DOES NOT guarantee the winner a spot at the “RBS Summer Friday” event, but secondary Grand Prize winners will still be eligible for the random selection process that will take place to determine Grand Prize winners in the Promotion.

- d. The gift cards will be mailed to the winners to the address provided in the online entry form. The winner will forfeit any prize or prize certificate not claimed within thirty (30) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. #### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. All winners of the secondary Grand Prize will be determined based on the amount of time it takes for five (5) entries to be received on [www.ESPNClevelandContests.com](http://www.ESPNClevelandContests.com) and all five (5) winners will be notified of winning by an ESPN Cleveland representative on the next business between the hours of 9AM and 6PM ET.
- c. The Grand Prize winners will begin to be randomly selected and notified of winning by an ESPN Cleveland representative on Monday, September 11, 2023, between the hours of 9AM and 6PM ET.
- d. The final winner will be randomly selected and notified of winning by an ESPN Cleveland representative by Tuesday, September 12, 2023, by 12PM ET.
- e. Odds of winning a prize in this Promotion depends upon the number of entries received, the ability to meet eligibility requirements, and random selection.
- f. Secondary Grand Prize winners will be determined based on the time stamp of their entry. The five (5) earliest entry times will be awarded the secondary Grand Prize.
- g. Secondary Grand Prize winners should listen to 850 ESPN Cleveland on Friday, September 1, 2023, to win. Secondary Grand Prize winners need not be present to win.
- h. Grand Prize winners need not listen to 850 ESPN Cleveland to win. Grand Prize winners need not be present to win.
- i. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement.
