

Reynolds Spring Yard Cleanup & Mulch

OFFICIAL RULES

ESPN Cleveland and Reynolds Property Management are giving fans the opportunity to win a single yard service providing cleanup and mulch. Fans may visit www.ESPNclevelandContests.com and fill out the registration form to enter. The contest will begin on Monday, April 8, 2024 at 10:00AM ET and end on Sunday, May 5, 2024 at 11:59PM ET. There will be one (1) winner randomly selected for this contest. Participants must be 18 years of age or older at the time of entry, and only one (1) internet entry per person will be allowed. Property for cleanup must be located within Cuyahoga, Summit, Portage, or Geauga County. The total ARV of the prize is \$1000.

1. HOW TO ENTER

These rules govern the Reynolds Spring Yard Cleanup & Mulch promotion (the "Promotion") being conducted by ESPN Cleveland, 1109 Old River Road, Cleveland, OH 44113 ("GKB") beginning 10:00AM EST on Monday, April 8, 2024 and ending 11:59PM EST on Sunday, May 5, 2024.

a. To participate in the Promotion, you may enter via the following method(s):

- Complete the online register-to-win form at www.ESPNclevelandContests.com
- i. To participate in the Promotion, you may log onto www.ESPNclevelandContestes.com and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not

received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each entrant must agree to GKB's online submission release in order to submit his or her entry.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 years old and older and who reside in Cuyahoga, Summit, Portage, or Geauga County in the state of Ohio. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. One (1) prize will be awarded in this Promotion. The prize consists of the following:
 - Spring lawn cleanup
 - Remove leaves and debris from beds and lawn
 - Trim/shape shrubs
 - Edge beds and lawn
 - Mulch (double shredded, choice of black, brown, red, or natural)
- i. Prize covers lots up to 1 acre (including dwelling) located in Cuyahoga, Summit, Portage, or Geauga County, Ohio. Volume of mulch provided depends on lot size:
 - Less than 1/4 acre: Clean up + 6 yards of mulch
 - 1/4 - 1/3 acre: Clean up + 5 yards of mulch

- 1/3 - 2/3 acre: Clean up + 4 yards of mulch
 - 2/3 - 1 acre: Clean up + 3 yards of mulch
- b. All prizes or prize certificates may be picked up at the office of GKB at the address below. The winner will forfeit any prize or prize certificate not claimed within fourteen (14) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- c. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. Winner will be randomly selected from the eligible entries on Monday, May 6, 2024 between 9:00AM ET and 4:00PM ET.
- c. Odds of winning depends upon the number of eligible entries.
- d. Winners need not listen or be present to win.
- e. Winner will be notified by phone on Monday, May 6, 2024. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within fourteen (14) days of winning or prize will be forfeited and an alternate winner may be selected by random selection. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
