OFFICIAL RULES

94.5 ESPN Milwaukee, 100.5 ESPN Madison, 1430 ESPN Beaver Dam and Cover5 are giving away a \$500 cash prize on Monday, February 13, 2023. Fans may enter by logging onto www.Cover5.com or downloading and logging onto the Cover5 app on iOS or Android and follow the links and instructions to enter the Promotion and register a Cover5 account by submitting your first and last name, username, password, city, state, country, zip code, date of birth, gender, and a valid email address in the online entry form between Wednesday, January 11, 2023, and Sunday, February 12, 2023. There will be a total of (1) grand prize in the contest. The total ARV of the Grand Prize is \$500.

1. HOW TO ENTER

- a. These rules govern the Scalzo and Brust Playoffs Cover5 Contest promotion (the "Promotion") being conducted by WKTI 94.5 ESPN 301 W Wisconsin Avenue, Suite 200, Milwaukee, WI 53203, WTLX 100.5 ESPN 821 E Washington Ave, Suite 500, Madison WI 53703, and 1430 ESPN 100 Bill McCollum Way, Beaver Dam, WI 53916 ("GKB") beginning on Wednesday, February 11, 2023, at 7am CST and ending on Sunday, February 12, 2023, at 11:59 PM CST.
- b. To participate in the Promotion, you may enter via the following method(s):
 - i. To participate in the Promotion, you may log onto www.Cover5.com or download and log onto the Cover5 app on iOS or Android and follow the links and instructions to enter the Promotion and register a Cover5 account by submitting your first and last name, username, password, city, state, country, zip code, date of birth, gender, and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each

entrant must agree to GKB's online submission release in order to submit his or her entry.

- ii. Upon completion of account registration, entrants must proceed to join Scalzo & Brust Playoffs Cover5 Contest by entering code "SB23" on the Join Leagues page, and make selections for specified games throughout pro football postseason.
 - iii. Entrants must choose a side of the spread for five of the six games in the first round of the pro football postseason, and then every remaining game of the postseason thereafter. Points will be amassed based on that team's performance against the spread. Point spreads will be determined by Cover5. For example, if the entrant chooses Green Bay favored by (5) points, and Green Bay wins their game by (20) points, the entrant will receive (15) points for that pick. If the entrant chooses Green Bay favored by (5) points, and Green Bay loses by (20) points, the entrant will lose (25) points for that pick. Scores for individual game picks and overall scores can be a negative number.
 - iv. For the contest, (-5) points will be assessed for each of the picks that goes unmade.
 - v. The entrant with the most points based on their picks against the spread at the end of the pro football postseason will win the prize. In the event of a tie, all tied parties will split the winnings.
- c. Show times are subject to change based on breaking news and specialty content at the discretion of GKB. GKB has the right to not notify fans and to not update contest rules or the webpage when such situations occur.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are at least 18 years of age and who reside in the United States of America. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are eligible to participate but ineligible to win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.

- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. (1) grand prize will be awarded in this Promotion. Each prize consists of the following:

The Approximate Retail Value (“ARV”) of the prize is \$500. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- b. All prizes will be mailed upon completion of requisite accepting prize forms. The winner will forfeit any prize or prize certificate not claimed within forty-five (45) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- c. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. Winner will be determined based on score on the day following the final day of the pro football postseason and be notified by Wednesday the following week.
- c. Odds of winning a Prize depends upon the number of entries and will be based on the entrant’s team selections in the pro football playoffs.
- d. The Promotion will yield winners based on the ability to correct choose the best winners against the spread.
- e. In the event of a tie score following the commencement of the postseason, all tied parties will split the overall Grand Prize evenly.
- f. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
