Six total prizes will be awarded during this promotion.

1. HOW TO ENTER

Occasionally the show may run out of Madison – 100.5 WTLX and on those days, you would text 844-770-3776.
 - i. To participate in the Promotion, beginning on February 13, 2023, at 4 PM CST and ending on February 17, 2023, at 6 PM CST, listeners must text a screenshot confirming their subscription, rating, and review of the Scalzo and Brust podcast and include “#Family” to the ESPN Milwaukee Talk & Text line.  - c. On Friday, February 17, 2023, once all five prizes have been given away, the five winners will qualify for the grand prize and be automatically entered to win the grand prize. These five winners will be the only ones entered to win the grand prize.
 - d. The grand prize winner will be chosen on Friday, February 17 between 4 PM CST and 6 PM CST.
 - e. Odds of a Qualifier winning the Grand Prize are 1 in 5.
 - f. Ben Brust and Greg Scalzo will determine which rating/review is best each day based on how funny and how impressive the review is.
