There will be a total of one (1) grand prize winner selected at random from the eligible form entries. Fans may enter by registering to win online at www.ESPNWisconsinContests.com between 7:00am CST on Friday, October 28, 2022, and 11:59pm CST on Sunday, November 20, 2022. There will be a total of one (1) grand prize in the contest. The total ARV of the Grand Prize is \$2,500.00.

1. HOW TO ENTER

- a. These rules govern the Scalzo and Brust Vegas Trip Giveaway promotion (the "Promotion") being conducted by 94.5 ESPN, WKTI, 301 W Wisconsin Ave, Suite 200, Milwaukee, WI 53203 ("GKB") beginning on Friday, October 28, 2022, at 7:00am CST and ending on Sunday, November 20, 2022, at 11:59pm CST.
- b. To participate in the Promotion, you may enter via the following method(s):
 - a. Submit your online entry form at www.ESPNWisconsinContests.com
 - i. To participate in the Promotion, you may log onto www.ESPNWisconsinContests.com and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. 2. ELIGIBILITY RESTRICTIONS

3. PRIZES

- a. One (1) grand prize will be awarded in this Promotion. Each prize consists of the following:
 - A trip to Vegas with Scalzo and Brust, which includes airfare, hotel, and spending cash

Airfare for two people to Las Vegas from Milwaukee in spring of 2023. The Prize also includes hotel arrangements and spending cash for two. The Approximate Retail Value ("ARV") of the prize is \$2,500.00. Certain travel restrictions may apply. Travel arrangements must be made through GKB. Prize is subject to availability. If the winner cannot travel on dates specified by GKB, the winner may be disqualified and an alternate winner may be selected in GKB's sole discretion. - c. The grand prize winner will be determined by 5:00pm CST on Tuesday, November 22, 2022.
- d. Odds of winning a Qualifying Prize depends upon the number of online entries received, the ability to meet the eligibility requirements, and random selection.
- e. Fans must complete the online entry form and be randomly selected in order to win.
- f. - e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes.
