

## SNOOP DOGG AT POTAWATOMI CASINO HOTEL TICKET GIVEAWAY

### OFFICIAL RULES

- Thursday, May 30, 2024: Ben Brust to give away one (1) pair of tickets during Kyle, Brust and Nortman (2pm CST – 5pm CST) and Jen Lada to give away one (1) pair of tickets during Jen, Gabe and Chewy (7am CST – 9am CST)
- Friday, May 31, 2024: Ben Brust to give away one (1) pair of tickets during Kyle, Brust and Nortman (2pm CST – 5pm CST) and Jen Lada to give away one (1) pair of tickets during Jen, Gabe and Chewy (7am CST – 9am CST)

The contest will begin on Thursday, May 23, 2024, and end on Friday, May 31, 2024. Fans may enter by being the correct caller during 94.5 ESPN Jen, Gabe, and Chewy between 7:00am CST and 9:00am CST or 94.5 ESPN Kyle, Brust and Nortman between 2pm CST and 5pm CST when prompted by hosts of the show. There will be a total of twelve (12) grand prizes in the contest. Each Grand prize will consist of two (2) tickets to Snoop Dogg at Potawatomi Casino Hotel taking place on June 15, 2024, at 9pm CST. The total ARV of each Grand Prize is \$178.

#### 1. HOW TO ENTER

- a. These rules govern Snoop Dogg at Potawatomi Casino Hotel Ticket Giveaway promotion (the “Promotion”) being conducted by WKTI 94.5 ESPN Milwaukee 301 W Wisconsin Ave, Suite 200, Milwaukee, WI 53203 (“GKB”) beginning on Thursday, May 23, 2024, and ending on Friday, May 31, 2024.
- b. To participate in the Promotion, you may enter via the following method(s):

- a. Listening for the cue to call during Jen, Gabe, and Chewy on 94.5 ESPN from 7:00AM CST to 9:00AM CST beginning Thursday, May 23, 2024, and ending on Friday, May 31, 2024.
  - b. Listening for the cue to call during Kyle, Brust and Nortman on 94.5 ESPN from 2:00PM CST to 5:00PM CST beginning Thursday, May 23, 2024, and ending on Friday, May 31, 2024.
- i. To participate in the Promotion, you must listen to Jen, Gabe and Chewy on weekdays from 7AM CST – 9 AM CST and/or Kyle, Brust and Nortman on weekdays from 2 PM CST – 5 PM CST on 94.5 ESPN beginning on Thursday, May 23, 2024, and ending on Friday, May 31, 2024, during the time of the promotion for the announcement of the cue to call. Upon hearing the cue to call, the designated number caller (as announced by the on-air personality prior to the cue to call) to get through to the ESPN Milwaukee contest line at 800-990-3776 will win a grand prize upon confirmation of eligibility. At the time of their call, callers will be required to provide all information requested including their full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. In the event that the selected caller is disconnected or is found to be ineligible, the next eligible caller that successfully makes it through on the call-in line and completes their call will be a winner. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once. There will be up to a total of (2) winners selected on-air during the Promotion dates. ## 2. ELIGIBILITY RESTRICTIONS

Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, [other radio stations in the Milwaukee metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to

participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
