

Soccer Dream Ticket Sweepstakes

OFFICIAL RULES (“Official Rules”)

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. HOW TO ENTER

- a. These official rules govern Soccer Dream Ticket Sweepstakes promotion (“Promotion”) being conducted by ESPN LA – Good Karma Broadcasting, LLC, 800 W. Olympic Blvd, Suite A200, Los Angeles, CA 90015 (“GKB”) beginning on Friday, August 1, 2025 at 9:00 AM Pacific Time (“PT”) and ending on Tuesday, September 30, 2025 at 11:59 PM PT (“Promotion Period”). Entrants must listen for the cue to call on KSPN-AM, get through the contest line, and be Caller Number 7 to win.
- b. To participate in the Promotion, you may enter via the following method:
 - i. To participate in the Promotion, you may log onto <https://goodkarmabrands.com/soccerdreamticket/> and follow the instructions to enter the Promotion and submit your first and last name, city, state, zip code, telephone number, date of birth and a valid email address in the online entry form.
 - ii. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB’s computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each entrant must agree to GKB’s online submission release in order to submit his or her entry.
- c. Fans may call in as many times to try and reach the KSPN-AM 710 contest line.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who: (i) are 21 years of age or older; and (ii) are legal residents of the 50 United States including Washington D.C. ("Eligibility Area"). Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and any of their respective subsidiaries or affiliated entities, advertising and promotional agencies, participating sponsors, and all other corporations, partnerships, or other legal entities or individuals associated with the development, administration, or fulfillment of this Promotion (collectively the "Promotion Parties"), and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must complete the required winner affidavits and provide valid government-issued photo identification, his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. Subject to compliance with all of the terms and conditions of these Official Rules, the grand prize winner will receive:
 - (1) Two (2) single-game tickets to the 2025 Final Soccer Match of the Season ("Match") at a stadium ("Arena"), date to be determined at a later date
 - (2) U.S. domestic round-trip coach class airfare (from a major gateway city near winner's home as determined by GKB in its sole discretion) for winner and one (1) guest of winner to the U.S city that is hosting the Match, date to be determined at a later date. If potential grand prize winner is within a 200 mile radius of the Match, ground transportation will be provided.
 - (3) One (1) double-occupancy hotel room for two (2) nights for winner and winner's guest at a hotel in the U.S city hosting the Match, to be determined by GKB in its sole discretion. Dates of stay to be determined by GKB in its sole discretion.

Travel arrangements must be made through GKB. Prize is subject to availability. If the winner cannot travel on dates specified by GKB only as a result of time restrictions to obtain required travel documentation, GKB in its sole discretion, may allow alternate travel dates to occur within the 2026 SOCCER preseason or regular season. All other costs not specifically stated herein, including but not limited to

those of, taxes (if applicable), visa/ESTA, meals, tips and ground transportation to/from the airport and/or to/from the hotel, are the responsibility of the winner and the winner's guest. The winner and winner's guest must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, any required visa/ESTA and passports for international travel. If applicable, the winner may be required to present a valid credit card upon hotel check-in to cover any incidental expenses incurred during the winner's stay. The winner and winner's guest must sign a Publicity, Liability Waiver and Travel Release form prior to traveling (each such document being a restatement and confirmation of certain aspects of these Official Rules). If the Match is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, or for any reason beyond the control of GKB, GKB's sole responsibility to the winner will be to award the remaining available portion of the prize and no substitution or compensation will be provided for the unawarded portion of the prize. GKB reserves the right to remove or to deny entry to the winner and/or travel companion(s) if either engages in a disruptive manner or with intent to annoy, abuse, threaten or harass any other person at any time. No responsibility is assumed by GKB or any other Promotion Parties for any cancellation, delay, suspension or postponement of any SOCCER match or other prize activity. For any SOCCER match tickets awarded as a prize, the actual seat locations of the game tickets shall be determined by GKB or its prize providers in their sole discretion, and no alternate dates will be available for such game tickets. The winner's guest must be the age of majority or older in their jurisdiction. SOCCER game tickets and admission to the Arena are subject to all security, fan conduct, safety and health requirements and policies put in place by SOCCER, and its affiliates and subsidiaries, and the Arena, as they may be updated from time to time. Any winner of SOCCER and Arena tickets and any guest of any such winner must also comply with all applicable SOCCER ticket terms and conditions and all applicable laws, rules, regulations, ordinances, policies, orders, protocols, and guidelines issued by federal, state, and local authorities respecting COVID-19 and other communicable diseases, and attendance at the Match is conditioned on such compliance.

The Approximate Retail Value ("ARV") of the prize is \$5,000. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- b. All prizes will be claimed via email account. The winner will forfeit any prize or prize certificate not claimed within twenty-four (24) hours of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- b. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The

prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

(4) WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. Friday, August 1, 2025 through Tuesday, September 30, 2025 will be the only days to enter. Winners will be determined by Friday, October 3, 2025.
- c. Odds of winning a Grand Prize depends upon the number of entries received. Grand Prize winner will be selected at random at the conclusion of the Promotion Period.
- d. Entrants are not required to listen to KSPN-AM to win. Grand Prize winner need not be present to win.
- e. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within five (5) days of winning or prize will be forfeited and an alternate winner may be selected from the pool of entries using the same method outlined in Section 4.c. (each such document being a restatement and confirmation of certain aspects of these Official Rules). If a potential winner cannot be contacted, or, to the extent permitted by applicable law, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize, and GKB may, in its sole discretion, select an alternate winner in a manner determined by GKB.

(5) CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by GKB in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.
- b. By participating in the Promotion, the winner agrees to have the winner's name, voice and likeness used in any advertising or broadcasting material relating to the Promotion without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.
- c. Prior to awarding any prize or prize certificate, GKB, in its sole discretion, may require Promotion winner(s) (and any travel companion(s) or guest(s)) to sign a

liability release, agreeing to release and hold harmless GKB, its subsidiary and affiliated entities, their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns from and against any and all claims or liability arising directly or indirectly from the prize and participation in the Promotion.

- d. If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of GKB, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, GKB reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Promotion and shall not be required to award a substitute prize.
- g. GKB is not responsible for typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize.
- h.
