

## 2025 SPRING TRAINING FLYAWAY WITH CIRCLE K

### OFFICIAL RULES

850 ESPN Cleveland and Circle K are giving away a trip for two (2) to Arizona to watch Cleveland baseball at Spring Training on December 30<sup>th</sup>, 2024. Fans may enter by registering online or scanning the contest QR code found at participating Circle K stores in Northeast Ohio between Monday, November 4<sup>th</sup> at 5:00PM ET and Friday, December 27<sup>th</sup>, 2024 at 11:59PM ET. There will be a total one (1) grand prize awarded in the contest. The total ARV of the Grand Prize(s) is \$2,500.

#### 1. HOW TO ENTER

- a. These rules govern the 2025 Spring Training Circle K Flyaway promotion (the "Promotion") being conducted by ESPN Cleveland (1109 Old River Road, Cleveland, Ohio, 44113) ("GKB") beginning on Monday, November 4<sup>th</sup> at 5:00PM ET and ending on Friday, December 27<sup>th</sup>, 2024 at 11:59PM ET.
- b. To participate in the Promotion, you may enter via the following method(s):
  - Complete an online register-to-win form by visiting [www.ESPNClevelandContests.com](http://www.ESPNClevelandContests.com)
  - Complete an online register-to-win form by scanning the contest QR code located at participating Circle K stores in northeast Ohio.
- i. To participate in the Promotion, you may log onto [www.ESPNClevelandContests.com](http://www.ESPNClevelandContests.com) and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due

to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each entrant must agree to GKB's online submission release in order to submit his or her entry.

## **2. ELIGIBILITY RESTRICTIONS**

- a. The Promotion is open to all persons who 18 years of age or older and who reside in the state of Ohio. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

## **3. PRIZES**

- a. One (1) grand prize will be awarded in this Promotion. The prize consists of the following:
  1. A trip for the winner plus one guest to Arizona to watch a Cleveland baseball game during Spring Training.

Airfare for two (2) people Phoenix, AZ from Cleveland, OH March 14-17, 2025  
The Prize also includes a hotel stay and two (2) tickets to one Cleveland baseball during Spring Training. The Approximate Retail Value ("ARV") of the prize is \$2,500 (Two thousand, five-hundred dollars). Certain travel restrictions may apply. Travel arrangements must be made through GKB. Prize is subject to availability. If the winner cannot travel on dates specified by GKB, the winner may be disqualified and an alternate winner may be selected in GKB's sole discretion. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and ground transportation to/from the airport and/or to/from the hotel, are the responsibility of the winner. The winner and travel

companion(s) must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. If applicable, the winner may be required to present a valid credit card upon hotel check in to cover any incidental expenses incurred during the winner's stay. The winner and travel companion(s) must sign a Publicity, Liability Waiver and Travel Release form prior to traveling. If a selected event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, or for any reason beyond the control of the Station, the Station's sole responsibility to the winner will be to award the remaining available portion of the prize and no substitution or compensation will be provided for the unawarded portion of the prize. GKB reserves the right to remove or to deny entry to the winner and/or travel companion(s) if either engages in a disruptive manner or with intent to annoy, abuse, threaten or harass any other person.

- b. All prizes or prize certificates will be transferred electronically to the email address provided at registration. The winner will forfeit any prize or prize certificate not claimed within forty-five (45) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate
- c. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

## **2. WINNER SELECTION AND NOTIFICATION**

- a. Decisions of GKB management with respect to the Promotion are final.
- b. The winner will be selected randomly from all qualified entries on Monday, December 30, 2024. The winner will be notified by phone by 6:00PM ET of the same day.
- c. The winner will be selected and notified on Monday, December 30, 2024.
- d. Odds of winning a Qualifying Prize depends upon the number of qualified entries received.
- e. The Grand Prize winner need not listen or be present to win.
- f. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited

and an alternate winner may be selected randomly. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

### **3. CONDITIONS**

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a

Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
