

## Steinhafels Smoker Giveaway

### OFFICIAL RULES

#### CONTEST

ESPN Wisconsin will execute a contest to giveaway one (1) meat smoker courtesy of Steinhafels. Listeners can enter for the chance to win by submitting a picture of their best smoked meat to the @WildeAndTausch Twitter account and using #steinhafelssmoker. Jason Wilde and Mark Tauscher will then decide on a winner together at the conclusion of the entry period. Entries may be submitted from 10 AM CST on Tuesday, May 21, 2019 through 8 AM CST on Thursday, May 23, 2019.

#### 1. HOW TO ENTER

- a. These rules govern the Steinhafels Smoker Giveaway promotion (the "Promotion") being conducted by WTLX 100.5 ESPN Madison, WTKI 94.5 ESPN FM, and WAUK 540 ESPN ("GKB") beginning on Tuesday, May 21, 2019 at 10 AM CST and ending on Thursday, May 23, 2019 at 8 AM CST.
- b. To participate in the Promotion, you may enter via the following method(s):
  - Twitter: tweet a photo to @WildeAndTausch and tag #steinhafelssmoker
- i. To participate in the Promotion, you may visit <https://twitter.com/WildeAndTausch> ("Page"). If you do not already "Follow" the Page, the you must "Follow" the Page in order to participate in the Promotion. Tweet a photo of your best smoked meat and tag the @WildeAndTausch account as well as #steinhafelssmoker to enter. You must tweet your photo between the hours of 10 AM CST on Tuesday, May 21, 2019 and 8 AM CST on Thursday, May 23, 2019. You must have a valid Twitter account in order to enter. If you do not already have one, you can create a Twitter account at no cost by visiting <http://www.twitter.com>. Limit one (1) entry per eligible person during the Entry Period regardless if entrant has more than one email address or Twitter account. Multiple participants are not permitted to share the same email address or Twitter account. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by GKB. Internet entrants are subject to all notices posted online including but not limited to GKB's Privacy Policy. ## 2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 years of age or older and who reside in the Greater Madison or Milwaukee Area. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, [other radio stations in the Madison or Milwaukee metropolitan area] and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every thirty (30) days and only once every six (6) months if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.

- b. All prizes or prize certificates will be delivered via a Best Buy store location. Winner information will be provided to Steinhafels, who will then facilitate delivery with Best Buy. The winner will forfeit any prize or prize certificate not claimed within forty-five (45) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.

- b. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

#### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. One winner will be selected between the hours of 8 AM CST and 10 AM CST on Thursday, May 23, 2019. The winner will be determined by Jason Wilde and Mark Tauscher dependent on how appealing the entrant's photo submission looks.
- c. The final winner will be known by 11 AM CST on Thursday, May 23, 2019.
- d. Odds of winning the Grand Prize depends upon the number of tweets received and the subjective appeal of the photo submitted as judged by Jason Wilde and Mark Tauscher.
- e. Qualifiers need not listen to WTLX 100.5 ESPN Madison, WKTJ 94.5 ESPN FM, or WAUK 540 ESPN to win. Qualifiers and the Grand Prize winner need not be present to win.
- f. The winner will be contacted via direct message on Twitter. The winner's Twitter handle will also be announced on Wilde And Tausch between the hours of 10 AM CST and 11 AM CST on Thursday, May 23, 2019. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited and an alternate winner may not be selected.
