

ESPN New York - Super Box Bonanza VI Promotion

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

ESPN New York is giving away big game boxes and corresponding prizes. Fans may enter by being the correct caller weekdays during DiPietro and Rothenberg (between 6:00 AM ET and 10:00 AM ET), Bart & Carlin (between 10:00 AM ET and 1:00 PM ET), The Michael Kay Show (between 1:00 PM ET and 3:00 PM ET) and Don, Hahn, and Rosenberg (between 3:00 PM ET and 7:00 PM ET) between January 21, 2025 and February 6, 2025. There will be a total of one hundred ten (110) qualifying prizes and four (4) grand prizes in the contest. The total ARV of all prizes are \$4,495.99.

1. HOW TO ENTER

- a. These rules govern the ESPN New York - Super Box Bonanza VI Promotion (the “Promotion”) being conducted by Good Karma Broadcasting LLC, ESPN New York, 155 Avenue of the Americas, 5th Floor, New York, New York 10013 (“GKB”) beginning at 6:00 AM ET on January 21, 2025 and ending at 7:00 PM ET on February 6, 2025.
- b. To participate in the Promotion, you may enter via the following method(s):
 - i. Listen to 880 AM – WHSQ – ESPN New York weekdays during DiPietro & Rothenberg (between 6:00 AM ET and 10:00 AM ET), Bart & Carlin (between 10:00 AM ET and 1:00 PM ET), The Michael Kay Show (between 1:00 PM ET and 3:00 PM ET) and Don, Hahn, and Rosenberg (between 3:00 PM ET and 7:00 PM ET) beginning on January 21, 2025 and ending on February 6, 2025 for the announcement of the cue to call. Upon hearing the cue to call, the designated number caller (as announced by the on-air personality prior to the cue to call) to get through to the GKB contest line at 1-888-987-3776 will be awarded a box and the qualifying prize associated with the selected box upon confirmation of

eligibility. At the time of their call, callers will be required to provide all information requested including their full name, complete address (including zip code), day and evening phone numbers, date of birth and be ready to select a box (1-100) in order to be eligible to win. If selected box is already taken, caller will be informed to select another box that is available. In the event that the selected caller is disconnected or is found to be ineligible, the next eligible caller that successfully makes it through on the call-in line and completes their call will be a winner. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once. There will be up to a total of one hundred (100) qualifiers selected on-air during the Promotion dates. GKB is not responsible for telephone service outages, delays, busy signals, equipment malfunctions or any other technological difficulties that may prevent an individual from completing his/her telephone call. Due to delays in the GKB online streaming of its broadcast signal, listeners to the online stream may not be able to participate in or may be disadvantaged in participating in on-air contests. Show times are subject to change based on breaking news and specialty content at the discretion of GKB. GKB has the right to not notify fans and to not update contest rules or the webpage when such conditioners occur.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 years of age or older as of entry and who reside in the New York City metropolitan area (NY, NJ, CT, PA). Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, other radio stations in the New York City metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.

- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. Up to one hundred fourteen (114) total prizes will be awarded in this Promotion. Prizes consist of the following:

Approximate retail value (“**ARV**”) of all qualifying prizes: \$500.00.

Approximate retail value (“**ARV**”) of all Super Box qualifying prizes: \$1,995.99.

Under no circumstances will total ARV of all qualifying prizes exceed \$2,495.99.

Grand Prizes: Up to three (3) End of Quarter and one (1) Final Score Grand Prizes are available to be won:

1st Quarter Grand Prize- \$250.00

2nd Quarter Grand Prize- \$500.00

3rd Quarter Grand Prize- \$250.00

Final Score Grand Prize- \$1,000.00

Cash prizes will be awarded in the form of a check.

Approximate retail value (“**ARV**”) of each grand prize: \$250.00 to \$1,000.00. Under no circumstances will total ARV of all Grand Prizes exceed \$2,000.00.

- b. The winner will forfeit any prize or prize certificate not claimed within seven (7) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- c. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. Qualifiers will be selected weekdays during DiPietro & Rothenberg (between 6:00 AM ET and 10:00 AM ET), Bart & Carlin (between 10:00 AM ET and 1:00 PM ET), The Michael Kay Show (between 1:00 PM ET and 3:00 PM ET) and Don, Hahn, and Rosenberg (between 3:00 PM ET and 7:00 PM ET) beginning on January 21, 2025 and ending on February 6, 2025.
- c. On Friday, February 7th, 2025 during DiPietro & Rothenberg each confirmed Qualifier who has received a Super Box will be randomly assigned with a number between 0-9 to be placed one number above each column horizontally on the top of a box grid (AFC Team) and during The Michael Kay Show each confirmed Qualifier will be randomly assigned to another number between 0-9 to be placed one number left of each row vertically on the side of the box grid (NFC Team) (the randomly assigned number for each of the AFC Team and NFC Team shall be known as a "Super Box Holder"). At the end of play in the first quarter, halftime, third quarter and the final (4th quarter or overtime if necessary) of the big game currently scheduled to take place on February 9, 2025, the winner will be determined by the Qualifier's name in the box grid square that has the correct last digit of each team's final score. For example: If the final score is AFC Team 35 and NFC Team 39, should any Super Box Holder have a square that aligns from AFC 5 and NFC 9, then that Super Box Holder would win the prize associated with the final score. Only the LAST digit of each score determines eligible numbers.
- d. All point determinations are official under National Football League rules.
- e. If no potential winner is determined by the end of the big game, or if any potential winner is found to be ineligible or otherwise not in compliance with these Official Rules, no prize will be awarded and such potential winner will be disqualified without compensation of any kind. No more than the stated number of prizes will be awarded. If the big game is canceled, GKB at its own discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any or all of the prizes or gift card prizes offered herein.

- f. Odds of winning depends upon the number and order of calls received.
- g. Qualifiers must listen to 880 AM – WHSQ – ESPN New York to win. Listeners need not be present to win.
- h. The qualifiers and winners must execute and return any required affidavit of eligibility and/or liability/publicity release within seven (7) days of winning or prize will be forfeited and an alternate winner may be selected. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential qualifiers and winners forfeit the prize.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. - b. By participating in the Promotion, the winner agrees to have the winner's name, voice and likeness used in any advertising or broadcasting material relating to the Promotion without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.

Prior to awarding any prize(s) or prize certificate(s), GKB, in its sole discretion, may require Promotion winner(s) to sign a liability release, agreeing to release and hold harmless GKB, its subsidiary and affiliated entities, their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns from and against any and all claims or liability arising directly or indirectly from the prize and participation in the Promotion.

If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).

- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.

- f. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of GKB, any competition or prize-related event or travel is delayed, rescheduled, postponed or canceled, GKB reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Promotion and shall not be required to award a substitute prize.

- g. GKB is not responsible for typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize.
