Contest

ESPN Milwaukee will execute TBD Cup to give a fan and a guest of their choice a chance to golf with Tony Smith and Bryan Dee at Whistling Straits on Saturday, July 27th, 2019. To participate, fans must submit a short video on Twitter using the #TBDCup and tagging @ESPNMilwaukee explaining why they deserve to golf with Tony and Bryan at Whistling Straits. Fans have from Monday, July 15th, 2019 through Friday, July 19th, 2019 to submit their video with the winner being chosen based on the story submitted on Monday, July 22nd, 2019. The winner will be allowed to bring one (1) guest to play as a foursome with Tony and Bryan.

1. HOW TO ENTER

 - Submit a short video on Twitter using the #TBDCup and tagging @ESPNMilwaukee explaining why you deserve to golf at Whistling Straits.
- i. To participate in the Promotion, you may visit @ESPNMilwaukee on the Twitter app. If you do not already "Follow" the Page, the you must "Follow" the Page in order to access the Promotion. You must have a valid Twitter account in order to enter. If you do not already have one, you can create a Twitter account at no cost by visiting <http://www.twitter.com>. 2. ELIGIBILITY RESTRICTIONS

- c. Odds of winning depends upon the number of entries and the discretion of Tony Smith and Bryan Dee as to which video submission is the best.
- d. Qualifiers must follow ESPN Milwaukee on Twitter to win. Qualifiers and the Grand Prize winner need not be present to win.
