

Taking a Step Back in Time - Twitter Contest

CONTEST

ESPN Madison is executing a contest to give away one (1) ESPN Madison prize pack. We are asking you to take a step back in time with us on Scalzo and Brust from Monday, August 19, at 3 PM CST to Friday, August 23, at 5 PM CST. The @Scalzo&Brust account on Twitter will ask fans to post their best/funniest throwback photo. Tweet at or tag @Scalzo&Brust your best/funniest throwback photo for your chance to win. There will be one winner announced on Friday, August 23, between 3 PM to 5 PM CST.

1. HOW TO ENTER

- a. These rules govern the “Taking a Step Back in Time Twitter Contest” promotion (the “Promotion”) being conducted by ESPN Madison, 15 N. Pinckney St, Suite 100, Madison, WI 53703 (“GKB”) beginning on Monday, August 19, 2019 at 3:00 PM CST and ending on Friday, August 23, 2019 at 3:00 PM CST.
- b. To participate in the Promotion, you may enter via the following method(s):
 - i. To participate in the Promotion, you may log onto www.Twitter.com (“Page”) and if you do not already “Follow” the account, then you must “Follow” @Scalzo & Brust on Twitter (<https://twitter.com/ScalzoandBrust>) in order to access the Promotion. You must have a valid Twitter account in order to enter and your Tweet Privacy must be set to un-protected. If you do not already have one, you can create a Twitter account at no cost by visiting <http://www.twitter.com>. Proof of submission of an entry shall not be deemed proof of receipt by GKB. Internet entrants are subject to all notices posted online including but not limited to GKB’s Privacy Policy. Use of Twitter as a means of entry will be subject to Twitter’s privacy policy and terms of service. By participating in the Promotion, entrant understands that he or she is providing his or her information to GKB and not Twitter. Further, entrant specifically agrees to release Twitter from any and all liability associated with this Promotion. The Promotion is in no way sponsored, endorsed or administered by, or associated with, Twitter. GKB is not responsible for entries not

received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems.

c. Entries are only accepted via Twitter follows. All entries must be submitted by 3 PM CST on Friday, August 23, 2019 to be considered for the promotion.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 years of age and older and who reside in the Greater Madison Metropolitan Areas. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. One (1) winner will be randomly selected on Friday, August 23, 2019 between 3 PM to 5 PM CST based on whoever tweets the best/funniest throwback photo while also tagging @Scalzo&Brust.
- c. The final winner will be determined by Friday, August 23, 2019 between 3 PM to 5 PM CST.
- d. Odds of winning the Prize depends upon the number of entries received and the selection by Greg Scalzo, Ben Brust, and Josh DiMaggio.
- e. Winner does not need to be present to win or listen to 100.5 ESPN.
- f. Winners will be announced on Friday, August 23, 2019 via Twitter. The winners will be contacted via direct message or a reply from the Scalzo and Brust account on Twitter. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited and the runner-up winner will be selected based on number of correct team predictions.
