Fans may enter by calling in to ESPN LA 710 AM during Sedano & Kaplan on Friday, December 7, 2023, between 4:00 PM PT and 7:00 PM PT. Caller number 7 will be selected as winner six times throughout the show. Event will be on Saturday, December 9, 2023 at Thunder Studios in Long Beach – hotel and transportation are not included in this promotion. There will be a total of (12) pairs of passes to the Tequila Mandala New Blood Boxing event. The total ARV of the Prize are \$100.

1. HOW TO ENTER

a. These rules govern the Tequila Mandala New Blood ticket giveaway promotion (the “Promotion”) being conducted by Good Karma Broadcasting, dba ESPN Los Angeles, 800 W. Olympic Blvd Suite 200, Los Angeles CA 90015 (“GKB”) on Friday, December 8, 2023, between 4:00pm PT and 7:00pm PT.

i. To participate in the Promotion, you may enter via the following method(s): Listen to SEDANO between 4:00 PM - 7:00 PM Pacific Time on Friday, December 8, 2023, for the cue to call 877-710- ESPN for the Tequila Mandala New Blood ticket giveaway promotion Promotion announcement. The seventh (7th) caller (each a “Qualifier”) will be asked to provide an answer to the question. At the time of their call, callers will be required to provide all information requested including their full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. In the event that the selected caller is disconnected or is found to be ineligible, the next eligible caller that successfully makes it through on the call-in line and completes their call will be a winner. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once. There will be up to a total of 5 winners selected on-air during the Promotion dates. ii. iii. 2. ELIGIBILITY RESTRICTIONS

b. Winners will be selected during ESPN LA 710 AM local programming on Friday, December 7, 2023, between 4:00 PM PT and 7:00 PM PT during the Sedano & Kaplan show. Fans must call into KSPN-AM and get through to the GKB contest line at 877-710-ESPN will win two (2) tickets to Tequila Mandala New Blood Boxing event.

c. There will be six (6) winners during the Promotion.

d. Failure to timely comply with any requirement, or supply any documents necessary for prize fulfillment or verification of identity and eligibility (collectively "Verification Documents"), or comply with these terms and conditions will result in a Qualifier being deemed ineligible for any prize.

disqualification and/or forfeiture of any prize or prizes.
