1. HOW TO ENTER

i. To participate in the Promotion, you may log onto Instagram or Twitter/X and follow the posting procedures to enter the Promotion and submit your golf video and tagging @espnlosangeles in the post. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the account submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same post. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited.
