

**ESPNLA TERRANEA RESORT LUXURY GETAWAY
OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.
A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.**

1. HOW TO ENTER

- a. These rules govern the ESPNLA Terranea Resort Luxury Getaway promotion (the "Promotion") being conducted by Good Karma Broadcasting, dba ESPN Los Angeles, 800 W. Olympic Blvd Suite 200, Los Angeles CA 90015 ("GKB") beginning on Sunday, October 23, 2022, at 10am Pacific and ending on Sunday, April 9, 2023 at 6pm Pacific time.
 - i. To participate in the Promotion, you must listen to KSPN-AM starting from Monday, October 31, 2022 to Thursday, November 3, 2022 between the hours of 1pm PST to 4pm PST. Callers will call in to 877-710-ESPN during the *Mason & Ireland* Show. The caller who can answer the *Lie of the Day* question will win the qualifying prize. We will randomly choose (1) grand prize winner from the (4) qualifying prize winners.
 - ii. Upon confirmation of eligibility. At the time of their call, callers will be required to provide all information requested including their full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. In the event that the selected caller is disconnected or is found to be ineligible, the next eligible caller that successfully makes it through on the call-in line and completes their call will be a winner. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once.
 - iii. There will be up to a total four (4) winners selected on-air during the Promotion dates. GKB is not responsible for telephone service outages, delays, busy signals, equipment malfunctions or any other technological difficulties that may prevent an individual from completing his/her telephone call. Due to delays in the GKB online streaming of its broadcast signal, listeners to the online stream may not be able to participate in or may be disadvantaged in participating in on-air contests. Show times are subject to change based on breaking news and specialty content at the discretion of GKB. GKB has the right to not notify fans and to not update contest rules or the webpage when such conditioners occur.
- b. Only one (1) entry per fan is permitted.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 or older and who reside in the United States. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. Current or former employees, family members, agents, successors, or assignees of the client or any promotional agency involved with this promotion shall be INELIGIBLE to participate. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities, or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. Winners do have to listen to 710 ESPN to win.
- c. The winners must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited, and an alternate winner may be selected by the same method as above. If a potential winner cannot be contacted, fails to sign, and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).

- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
