

The Dunk King Of Cleveland Shooting Competition Contest Rules

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

CONTEST OVERVIEW

ESPN Cleveland will execute a contest to give away forty (40) spots for fans to participate in The Dunk King Of Cleveland Shooting Competition Contest on Saturday, February 19th, 2022. The actual contest will take place at the Lakewood Family YMCA (16915 Detroit Ave, Lakewood, OH 44107) from 3PM EST to 5PM EST. The Dunk King of Cleveland Shooting Competition Contest includes the opportunity to participate in the shooting competition and a Grand Prize for the top finisher. Fans can enter for the chance to qualify for spot via an online entry form at ESPNClevelandContests.com between the dates of Wednesday, February 2nd, 2022, and Thursday, February 17th, 2022. A total of forty (40) participants will be selected no later than Friday, February 18th, 2022.

1. HOW TO ENTER

- a. These rules govern The Dunk King Of Cleveland Shooting Competition Contest promotion (the "Promotion") being conducted by 850 ESPN Cleveland 1301 E. 9th Street, Suite 252, Cleveland, OH 44114 ("GKB") beginning on Wednesday, February 2nd, 2022, at 12 AM EST and ending on Saturday, February 19th, 2022 at 5 PM EST.
- b. To participate in the Promotion, you may enter via the following method(s):
 - Register online at ESPNClevelandContests.com
 - i. To participate in the promotion, you may log onto ESPNClevelandContests.com between Wednesday, February 2nd, 2022, at 12 AM EST and ending on Thursday, February 17th, 2022, at 8:00 PM EST and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of the entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address of the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or

returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems.

- ii. Once a Qualifying Prize has been awarded, the qualifier must compete in The Dunk King Of Cleveland Shooting Competition contest on Saturday, February 19th, 2022, in order to be eligible for the Grand Prize, which will take place at the Lakewood Family YMCA (16915 Detroit Ave, Lakewood, OH 44107) from 3PM EST to 5PM EST.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 years of age and above who reside in the state of Ohio. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, [other radio stations in the Cleveland metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every thirty (30) days and only once every six (6) months if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Winners must be available to attend the contest event in person on Saturday, February 19th, 2022 (location: Lakewood Family YMCA - 16915 Detroit Ave, Lakewood, OH 44107 - from 3PM EST to 5PM EST).
- e. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements. GKB will also delete any entry knowingly received from persons under the age of 13 in compliance with the Children's Online Privacy Protection Act.

3. PRIZES

- a. (40) Qualifying Prizes will be awarded in this Promotion. Each prize consists of the following:

- Qualifying Prize: (1) spot in The Dunk King Of Cleveland Shooting Competition contest on February 19th, 2022 (location: Lakewood Family YMCA - 16915 Detroit Ave, Lakewood, OH 44107 - from 3PM EST to 5PM EST).

Out of the (40) Qualifying Prize winners, there is the opportunity to win a Grand Prize for First place, which includes the following in addition to the Qualifying Prize:

- First Place Winner: \$1,000 cash, a \$200 Circle K gift card, and a Circle K prize pack

In addition to the experiential value of the Qualifying Prize, the Approximate Retail Value ("ARV") of the Grand Prize is \$1,250. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- All prizes or prize certificates will be given to the winners the day of the event. The winner must confirm that he/she will attend the event/game by the end of the day on Friday, February 18th, 2022, or he/she will forfeit the prize and another winner will be selected at random from the pool of entries from the online form. In addition, the winner will forfeit any prize or prize certificate not claimed on February 19th, 2022. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The Qualifying Prize is non-transferrable. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- Decisions of GKB management with respect to the Promotion are final.
- Participants will be notified by Friday, February 17th, 2022, if they have been selected to participate in The Dunk King Of Cleveland Shooting Competition Contest.
- Participants must RSVP by 11:59 PM EST Friday, February 18th, 2022, or else the prize will be forfeited and another winner will be randomly selected in their place.

- d. Participants must be present to qualify to receive the prizes on Saturday, February 19th, 2022.
- e. Odds of winning a Qualifying Prize depends upon the number of entries in this competition. Odds of a qualifier winning the Grand Prize on-site are dependent on the skill of each participant.
- f. Promotion of Skill:
 - 1. On Saturday, February 19th, 2022, 850 ESPN Cleveland and Circle K will conduct The Dunk King Of Cleveland Shooting Competition contest (location: Lakewood Family YMCA - 16915 Detroit Ave, Lakewood, OH 44107 - from 3PM EST to 5PM EST).
 - 2. The registration period to win a Qualifying Prize of (1) non-transferrable spot in The Dunk King Of Cleveland Shooting Competition contest will begin on Wednesday, February 2nd, 2022, at 12 AM EST and will end on Wednesday, February 16th, 2022, at 8:00 PM EST.
 - 3. All participants must have a valid picture ID and be at least 18 years of age or older.
 - 4. All participants must abide by the designated health and safety protocols.
 - 5. All participants must complete a liability/waiver form in order to participate.
 - 6. The hoop will be at a standard height of ten (10) feet, no higher or lower.
 - 7. Gameplay will proceed as follows, with structure based on number of participants:
 - a. If there are fewer than (20) participants, there will be two rounds, a First Round and a Final Round.
 - i. First Round:
 - 1. Each participant will have 120 seconds to complete the four-shot challenge, consisting of a lay-up, a free throw, a three-point shot, and a half-court shot, in that order.
 - a. Participants may not advance to the next shot in the order until they have executed a made basket on whatever stage they are on.
 - i. Participants will start with the lay-up. Once the participant makes a lay-up, they can advance to the free throw. Once the participant makes a free throw, they will advance to the three-pointer. Once that is made, they move to the final stage of the half-court shot.
 - b. Participants have unlimited attempts at each stage and must make that basket before advancing.
 - c. Each participant's round ends when they successfully complete the half-court shot, or at the

end of 120 seconds from the start of their round, whichever comes first.

2. The (5) participants with the fastest round times in the First Round will advance to the Final Round.
 - a. If (5) participants do not successfully complete all four shots, tiebreaker will be determined by which participant(s) completed the three-point shot quickest.

ii. Final Round:

1. Each of the (5) participants will have 120 seconds to complete the four-shot challenge, consisting of a lay-up, a free throw, a three-point shot, and a half-court shot, in that order.
 - a. Participants may not advance to the next shot in the order until they have executed a made basket on whatever stage they are on.
 - i. Participants will start with the lay-up. Once the participant makes a lay-up, they can advance to the free throw. Once the participant makes a free throw, they will advance to the three-pointer. Once that is made, they move to the final stage of the half-court shot.
 - b. Participants have unlimited attempts at each stage and must make that basket before advancing.
 - c. Each participant's round ends when they successfully complete the half-court shot, or at the end of 120 seconds from the start of their round, whichever comes first.
 2. The participant with the fastest Final Round time will be awarded the Grand Prize
 - a. If no participants successfully complete all four shots, tiebreaker will be determined by which participant(s) completed the three-point shot quickest.
- b. If there are between (20) and (40) participants, there will only be one round:
1. Each participant will have 120 seconds to complete the four-shot challenge, consisting of a lay-up, a free throw, a three-point shot, and a half-court shot, in that order.
 - a. Participants may not advance to the next shot in the order until they have executed a made basket on whatever stage they are on.
 - i. Participants will start with the lay-up. Once the participant makes a lay-up, they can advance to the free throw. Once the

participant makes a free throw, they will advance to the three-pointer. Once that is made, they move to the final stage of the half-court shot.

- b. Participants have unlimited attempts at each stage and must make that basket before advancing.
 - c. Each participant's round ends when they successfully complete the half-court shot, or at the end of 120 seconds from the start of their round, whichever comes first.
2. The participant with the fastest round time will be awarded the Grand Prize
- a. If no participants successfully complete all four shots, tiebreaker will be determined by which participant completed the three-point shot quickest.
 - b. If there is a tie between participants who completed the three-point shot quickest, those participants will move to another four-shot tiebreaker.
 - c. The four-shot process will continue round-after-round until a participant completes the four-shot challenge, or until one participant has the quickest time to complete the three-pointer.
- g. Qualifiers must be present day of the event during the specified times in order to win any of the prizes.
- h. All qualifiers of The Dunk King Of Cleveland Shooting Competition contest will be notified they have been selected to compete by phone, with the phone number they provided on their online submission form. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release prior to the start of the event. Extra copies will be provided on-site on Saturday, February 19th, 2022, and must be completed prior to participation. Any paperwork not submitted at this time will result in the prize being forfeited with no replacement. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by GKB in a calendar

year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.

- b. By participating in the Promotion, the winner agrees to have the winner's name, voice and likeness used in any advertising or broadcasting material relating to the Promotion without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.
- c. Prior to awarding any prize(s) or prize certificate(s), GKB, in its sole discretion, may require Promotion winner(s) (and any travel companion(s) or guest(s)) to sign a liability release, agreeing to release and hold harmless GKB, its subsidiary and affiliated entities, their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns from and against any and all claims or liability arising directly or indirectly from the prize and participation in the Promotion.
- d. If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of GKB, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, GKB reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Promotion and shall not be required to award a substitute prize.

- g. GKB is not responsible for typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize.
- h.
