

## THE REALLY BIG SHOW HOLIDAY REMIX CONTEST 2022

### OFFICIAL RULES

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.**

850 ESPN Cleveland is giving fans the chance to win a nice prize pack this holiday season with the return of *The Really Big Show's* Holiday Remix contest. Fans may enter by uploading a parody of a popular holiday song and filling out the entry form online at [www.ESPNClevelandContests.com](http://www.ESPNClevelandContests.com). The parody cannot exceed 45 seconds in length and must be Cleveland sports or *The Really Big Show* based. The period for entry will begin on Tuesday, November 29<sup>th</sup> and remain until Sunday, December 11<sup>th</sup>. From there, *The Really Big Show* cast will determine their top-5 entries as a team. The winner will then be decided by a panel of judges as they score each entry based on three categories: creativity, production value, and memorability. The highest scoring entry from the top-5 will be announced as the winner on Thursday, December 22<sup>nd</sup> no later than 1PM ET. If more than one entry receives the same score, a tie-breaking judge will be used to score the tied entries to determine the winner that is announced on December 22<sup>nd</sup>. The winner will receive a prize pack courtesy of The Cleveland Orchestra, Great Northern Mall, Hospitality Restaurants, and Dodd Camera valued at \$2,300.

#### 1. HOW TO ENTER

- a. These rules govern *The Really Big Show* Holiday Remix Contest 2022 promotion (the "Promotion") being conducted by ESPN Cleveland, 1109 Old River Road, Cleveland, OH 44113 ("GKB"). The entry period will begin on Tuesday, November 29, 2022, at 12AM EST and end on Sunday, December 11, 2022, at 11:59PM EST. The winner will be announced by 1PM ET on Thursday, December 22, 2022.
- b. To participate in the Promotion, you may enter via the following method(s):  
Submit your parody song and fill out the registration form online at [www.ESPNClevelandContests.com](http://www.ESPNClevelandContests.com).
  - i. To participate in the Promotion, you may log onto [www.espnlevelandcontests.com](http://www.espnlevelandcontests.com) and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth, a valid email address, and a parody song of a popular holiday song with lyrics involving content from *The Really Big Show* or Cleveland sports in the online entry form. All parody song submissions must be 45 seconds in length or less. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider,

online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each entrant must agree to GKB's online submission release in order to submit their entries.

- c. Only one internet entry per person and one internet entry per email address is permitted.

## 2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 21 years of age or older and who reside in The United States of America. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, other radio stations in the Greater Cleveland metropolitan area, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

## 3. PRIZES

- a. One (1) Grand Prize will be awarded in this Promotion. Each prize consists of the following:
  - Twenty (20) total tickets to five (5) Cleveland Orchestra shows in 2023 [ARV=\$1,000]
    - Four (4) tickets to their *Jurassic Park* show at Blossom Music Center

- Four (4) tickets to their *Lord of the Rings 2* show at Blossom Music Center
- Four (4) tickets to their “Sound of Magic” show at Blossom Music Center
- Four (4) tickets to their *West Side Story* show at Severance Music Hall
- Four (4) tickets to their “Opera: Girl of the Golden West” show at Severance Music Hall
- A collection of gift cards to retail stores and restaurants at Great Northern mall in North Olmsted, Ohio totaling \$525.
  - One (1) Dick’s Sporting Goods gift card - \$250
  - One (1) JCPenney gift card - \$100
  - Two (2) BJ’s Restaurant & Brewhouse gift card - \$100 & \$25
  - One (1) McAlister’s Deli gift card - \$50
- Two (2) drink glasses from BJ’s Restaurant and Brewhouse [ARV = \$25]
- Dinner for four (4) at one of Hospitality Restaurant’s locations [ARV = \$250] - \*Prize not valid to be used on holidays\*
- One (1) Dodd Camera gift card - \$500

The Approximate Retail Value (“ARV”) of the prize pack is \$2,300. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize. The gift cards in this prize pack will be subject to the terms and conditions as set forth by the issuer of the gift certificate.

- b. All prizes must be picked up at the office of GKB at the address below. The winner will forfeit any prize or prize certificate not claimed within forty-five (45) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- c. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

#### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. The Grand Prize winner will be selected by Thursday, December 22, 2022, by 1PM ET. An ESPN Cleveland representative will contact the winner after being

announced as the winner to discuss the next steps to get the winner their prize pack.

- c. Participants will submit a parody song of a popular holiday song with lyrics involving content from *The Really Big Show* and Cleveland sports in the online entry form.
  - Participants will have from Tuesday, November 29<sup>th</sup> to Sunday, December 11<sup>th</sup> to upload their parody song and fill out the online entry form online at [www.ESPNClevelandContests.com](http://www.ESPNClevelandContests.com).
  - All parody songs must be 45 seconds in length or less.
  - All parody songs must focus on some aspect of *The Really Big Show* or Cleveland sports.
  - Starting on Monday, December 12<sup>th</sup>, the members of *The Really Big Show* will begin listening to each entry and will determine the top-5 parody entries. These top-5 entries will be determined by Thursday, December 22<sup>nd</sup>.
  - During *The Really Big Show* on Thursday, December 22<sup>nd</sup>, a panel of three judges will listen to and judge each of the top-5 entries.
  - Each judge will rate each top-5 entry on a scale from 1-10 in three categories: creativity, production value, and memorability.
  - The entry that has highest cumulative score amongst the judges will be deemed the Grand Prize winner of this Promotion.
  - In the event of a tie, there will be a fourth judge designated as the tie breaking judge. They will rate each of the tied entries on a scale from 1-10 in three categories: creativity, production value, and memorability.
  - The entry among those that are tied that receives the highest cumulative score amongst the three categories, as rated by the tie breaking judge, will be deemed the Grand Prize winner of this Promotion.
- d. The Grand Prize winner must listen to 850 ESPN Cleveland to win. The Grand Prize winner need not be present to win.
- e. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited, and an alternate winner may be selected based on the next highest scoring song. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

## 5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by GKB in a calendar

year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.

- b. By participating in the Promotion, the winner agrees to have the winner's name, voice and likeness used in any advertising or broadcasting material relating to the Promotion without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.

Prior to awarding any prize(s) or prize certificate(s), GKB, in its sole discretion, may require Promotion winner(s) (and any travel companion(s) or guest(s)) to sign a liability release, agreeing to release and hold harmless GKB, its subsidiary and affiliated entities, their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns from and against any and all claims or liability arising directly or indirectly from the prize and participation in the Promotion.
- d. If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement.
