

BURN PIT BBQ – 2026 TOP 8@8

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

WKTI 94.5 ESPN Milwaukee is giving away twenty-two (22) prize packages, each consisting of Burn Pit BBQ Heat-Resistant Grilling Gloves and a Burn Pit BBQ Patriot Pack Bundle (8-pack) of Burn Pit BBQ Rubs, Sauces, and Seasonings, beginning on Thursday, April 30, 2026, and ending on Thursday, October 1st, 2026. Fans may enter by being the designated caller between approximately 7:00 AM/CT and 9:00 AM/CT, with the cue to call expected to occur at or around 8:30 AM/CT each Thursday. There will be a total of twenty-two (22) prizes in the contest. The total ARV of the prizes is \$2,332.00.

Gabe reveals a “Top 8” list to Jen and Chewy on any topic at approximately 8:00 AM/CT every Thursday during the Promotion Period. They guess until an incorrect answer is given or time expires, at which point listeners are invited to call in. The station will select, in its sole discretion, an eligible caller to attempt to complete the remaining answers on the predetermined list. If the caller correctly identifies all remaining answers, as determined solely by the station, they will be declared the winner. If the caller provides an incorrect answer, fails to respond, or is disconnected, the opportunity may be given to another caller, at the station’s discretion. All decisions by the station regarding gameplay, acceptable answers, and winner determination are final and binding.

HOW TO ENTER

- a. These rules govern the Top 8@8 promotion (the “Promotion”) being conducted by WKTI 94.5 ESPN Milwaukee, 301 W Wisconsin Ave, Suite 200, Milwaukee, WI 53203 (“GKB”) beginning on Thursday, April 30, 2026, at 7:00 AM/CT and ending on Thursday, September 24, 2026, at 9:00 AM/CT.
- b. To participate in the Promotion, you may enter via the following method(s):
 - i. To participate in the Promotion, you must listen to WKTI 94.5 ESPN Milwaukee each Thursday during the Promotion Period between approximately 7:00 AM/CT and 9:00 AM/CT for the announcement of the cue to call, which is expected to occur at or around 8:00 AM/CT. Upon hearing the cue to call, the designated number caller (as announced by the on-air personality prior to the cue to call) to get through to the GKB contest line at (800)-990-3776, will get to participate in the Top 8@8 segment. The show

hosts will present a topic of their choice and ask the other hosts to guess the top eight (8) answers within the topic. Once the hosts provide an incorrect answer or time expires, listeners will then be invited to call in, subject to eligibility verification. At the time of their call, callers will be required to provide all information requested including their full name, complete address (including zip code), day and evening phone numbers and date of birth to be eligible to win. If the selected caller is disconnected or is found to be ineligible, the next eligible caller that successfully makes it through on the call-in line and completes their call will be given the opportunity to participate. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once. There will be up to a total of twenty-two (22) winners selected on-air during the Promotion dates. GKB is not responsible for telephone service outages, delays, busy signals, equipment malfunctions or any other technological difficulties that may prevent an individual from completing his/her telephone call. Due to delays in the GKB online streaming of its broadcast signal, listeners to the online stream may not be able to participate in or may be disadvantaged in participating in on-air contests. Show times are subject to change based on breaking news and specialty content at the discretion of GKB. GKB reserves the right to modify programming and contest elements at its discretion due to breaking news, live events, or other unforeseen circumstances.

ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 years or older and who reside in the greater Milwaukee area. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, other radio stations in the Milwaukee metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.

- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

PRIZES

- a. Twenty-two (22) total prizes may be awarded in this Promotion. Each prize consists of the following:
 - Burn Pit BBQ Patriot Pack Bundle (8-pack)
 - Burn Pit BBQ Heat-Resistant Grilling Gloves

The Approximate Retail Value (“ARV”) of the prize is \$106. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- b. All prizes or prize certificates may be picked up at the office of GKB at the address below. The winner will forfeit any prize or certificate not claimed within thirty (30) days of winning. If a prize or prize certificate is mailed to the winner, it will be with prior written consent of the winner and therefore, winner assumes the risk of its loss. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. Winners will be selected at approximately 8:00 AM/CT every Thursday during the Promotion Period.
- c. Odds of winning depend on the number and order of calls received and the contestant’s ability to successfully complete the game.
- d. Listeners must tune in to WKTI 94.5 ESPN Milwaukee to participate. Winners need not be present to win.

- e. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by GKB in a calendar year with an aggregate value of \$600 or more. - b. If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with

the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to fully prosecute and seek damage permitted by law.

- f.
