

Top 8@8 – X-Golf

OFFICIAL RULES

Contest

94.5 ESPN Milwaukee will execute a contest to give away (6) X-Golf gift cards beginning on Thursday, April 7, 2022 at 7AM CT and ending on Thursday, May 12, 2022 at 9AM CT. Each week during the Promotion dates, fans can listen for the announcement of the cue to call into Jen, Gabe & Chewy from 7am-9am CST for a chance to win the gift card. The show host will pick a topic while the other hosts try to guess the top 8 within the topic. Once the hosts guess wrong, fans will be given an opportunity to try and finish the list. The designated number caller that gets through the contest line and is able to successfully finish the list will be deemed the winner upon confirmation of eligibility. There will be eight (8) winners selected through the Promotion dates. The ARV of each prize is \$25.00.

1. HOW TO ENTER

- a. These rules govern Top 8@8 (the “Promotion”) being conducted by WKTI 94.5 ESPN, 720 E Capitol Dr., Milwaukee, WI 53212 beginning on Thursday, November 11, 2021 and ending on Thursday, December 30, 2021.
- b. To participate in the Promotion, you may enter via the following method(s):
 - Cue to Call during on-air local programming
 - i. To participate in the Promotion, fans must listen to WKTI 94.5 ESPN beginning on Thursday, April 7, 2022 and ending on Thursday, May 12, 2022 between the hours of 7-9AM CT for the announcement of the cue to call. Upon hearing the cue to call, the designated number caller (as announced by the on-air personality prior to the cue to call) to get through to the GKB contest line at (800) 990-3776, will get to participate in the Top 8@8 segment. The show’s host will come up with a topic of their choice and ask the other hosts to guess the top 8 answers within the topic. Once the hosts each guess a wrong answer, fans will be invited to call in via the cue to call and finish the list. If a caller guesses a wrong answer, the next caller will be selected to try and finish the list. Whichever caller successfully finishes the list will be deemed the winner upon confirmation of eligibility. At the time of their call, callers will be required to provide all information requested including their full name, complete address (including zip code), day and evening phone numbers, date of birth, and email address in order to be eligible to win. In the event that the selected caller is disconnected or is found to be ineligible, the

next eligible caller that successfully makes it through on the call-in line and completes their call will be a winner. There is no limit to the number of times a listener may attempt to call in to win, but each listener may only win a prize once in a 7-day span. There will be (6) winners selected on-air during the Promotion dates. GKB is not responsible for telephone service outages, delays, busy signals, equipment malfunctions or any other technological difficulties that may prevent an individual from completing his/her telephone call. Due to delays in the GKB online streaming of its broadcast signal, listeners to the online stream may not be able to participate in or may be disadvantaged in participating in on-air contests.

- ii. Show times are subject to change based on breaking news and specialty content at the discretion of GKB. GKB has the right to not notify fans and to not update contest rules or the webpage when such situations occur.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are the age of 18 years and above and reside in the Greater Milwaukee Area. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, other radio stations in the Milwaukee metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address (Street, City, Zip Code), email address, and date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. Six (6) total prizes may be awarded in this Promotion. Each prize will consist of (1) \$25 gift card to X-Golf.

The Approximate Retail Value (“ARV”) of each prize is \$25.00. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize. Any gift certificates will be subject to the terms and conditions as set forth by the issuer of the gift certificates. Gift cards are only valid at the Brookfield X-Golf location located at 12565 W Feerick Street Unit C Brookfield, Wisconsin 53005.

- b. All prizes or prize certificates will be mailed to the winner. To officially claim the prize, the winner must complete all required prize forms provided by GKB. The winner will forfeit any prize or prize certificate not claimed within (30) days of being selected as a winner. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- c. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. All winners will be known following the conclusion of the Promotion on May 12, 2022.
- c. Odds of winning a prize depends on the order and number of calls received, and the ability to successfully complete the Top 8@8 list.
- d. Qualifiers must listen to WKTJ 94.5 ESPN to win. Prize winner need not be present to win.
- e. Winners will be notified by an employee of GKB via the phone number they provided to the show Producer. They will be informed within 72 hours of being selected the winner. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within (30) days of winning or prize will be forfeited. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by GKB in a calendar year with an aggregate value of \$600 or more. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
