

# TRICK-OR-CLE COSTUME CONTEST

## OFFICIAL RULES

Fans may enter by posting a picture of their best Cleveland-based Halloween Costume on Twitter or on [www.ESPNclevelandContests.com](http://www.ESPNclevelandContests.com) between Monday, October 10, 2022, at 12AM EST and Tuesday, November 1, 2022, at 11:59PM EST. To enter on Twitter, you must caption your photo with the hashtag, #ESPNOHalloween, and tag @ESPNOcleveland in the tweet. To enter on the website, upload the photo into the entry form and fill out all the required pieces of information. One lucky fan will be randomly selected from all the eligible entries as the winner of the contest. There will be a total of (1) grand prize in the contest. The total ARV of the grand prize is \$200.

### 1. HOW TO ENTER

- a. These rules govern the Trick-or-CLE Costume Contest (the “Promotion”) being conducted by ESPN Cleveland, 1109 Old River Road, Cleveland, OH 44113 (“GKB”) beginning on Monday, October 10, 2022, at 12AM EST and ending on Tuesday, November 1, 2022, at 11:59PM EST.
- b. To participate in the Promotion, you may enter via one of the following methods:
  - Tweet out a photo of your best Cleveland-based Halloween costume with the hashtag #ESPNOHalloween, and tag @ESPNOcleveland on Twitter.
  - Upload a photo of your best Cleveland-based Halloween costume on [www.ESPNclevelandContests.com](http://www.ESPNclevelandContests.com) and fill out the online entry form.
- i. To qualify for the Promotion using Twitter, you may visit <http://www.twitter.com> or the Twitter app on your smart device to post a picture of your best Cleveland-based Halloween costume, use the hashtag #ESPNOHalloween in your caption, and tag @ESPNOcleveland (“the Page”) in the post. If you do not already “Follow” the Page, you must “Follow” the Page in order to access the Promotion. You must have a valid Twitter account in order to enter. If you do not already have one, you can create a Twitter account at no cost by visiting <http://www.twitter.com>. You must also have your DMs open for an ESPN Cleveland representative to contact you. When contacted, you may be asked to provide some information such as your first and last name, complete address, city, state, zip code, telephone number, date of birth, and/or a valid email address. Limit one (1) entry per eligible person during the Entry Period regardless of if entrant has more than one Twitter account. Multiple participants are not permitted to share the same Twitter account. Entries submitted may not be acknowledged or returned.

Proof of submission of an entry shall not be deemed proof of receipt by GKB. Internet entrants are subject to all notices posted online including but not limited to GKB's Privacy Policy. Use of Twitter as a means of entry will be subject to Twitter's privacy policy and terms of service. The Promotion is in no way sponsored, endorsed, or administered by, or associated with, Twitter.

- ii. To qualify for the Promotion using photo upload, you may log onto [www.ESPNClevelandContests.com](http://www.ESPNClevelandContests.com) and follow the links and instructions to enter the Promotion to submit a photo of your best Cleveland-based Halloween costume, along with the following information: your first and last name, complete address, city, state, zip code, telephone number, date of birth and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems.
- c. Limit one (1) qualifying entry per eligible person during the entry period regardless of the platform that fans choose to post their photos, whether on Twitter or [www.ESPNClevelandContests.com](http://www.ESPNClevelandContests.com).

## 2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 years of age or older and who reside in the state of Ohio. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state, and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued

over \$600. Only one (1) winner per household is permitted in any GKB promotion.

- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

### 3. PRIZES

- a. One (1) prize will be awarded in this Promotion. Each prize consists of the following:

- One (1) Visa Gift Card

The Approximate Retail Value (“ARV”) of the prize is \$200. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize. The gift certificate will be subject to the terms and conditions as set forth by the issuer of the gift certificate.

- b. The gift card will be mailed to the winner. The winner will forfeit any prize or prize certificate not claimed within thirty (30) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- c. There is no substitution, transfer, or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities, or any other expenses. Other restrictions may apply.

### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. The winner will be randomly selected from all eligible entries and notified by phone, by an ESPN Cleveland representative on Wednesday, November 2, 2022, between 9AM EST and 6PM EST.

- c. Odds of winning the prize depends on the amount of Halloween costume submissions received.
- d. The winner need not listen to 850 ESPN Cleveland to win. The winner need not be present at time of drawing to win.
- e. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited, and an alternate winner may be randomly selected. If a potential winner cannot be contacted, fails to sign, and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

## 5. CONDITIONS

- a. Payments of all federal, state, and local taxes are solely the responsibility of the winner. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries

received as of the termination time/date or otherwise modify the procedure for selecting winner(s).

- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f.
