

ESPN LA – THE ULTIMATE WRESTLING EXPERIENCE

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. HOW TO ENTER

- a. These official rules govern the ESPN LA – The Ultimate Wrestling Experience promotion (“Promotion”) being conducted by ESPN LA – Good Karma Broadcasting, LLC, 800 W. Olympic Blvd, Suite A200, Los Angeles, CA 90015 (“GKB”) beginning on Monday, March 24, 2025 at 9:00 AM Pacific Time (“PT”) and ending on Monday, April 7, 2025 at 6:00 PM PT (“Promotion Period”). Entrants must check-in with the ESPN LA check-in table at Hollywood Park Casino, 3883 W Century Blvd, Inglewood, CA 90303 (“Event”) beginning Monday, April 7, 2025 at 3:00 PM PT and ending at Monday, April 7, 2025 at 5:00 PM PT. GKB is the sponsor and administrator of the Promotion.
- b. To participate in the Promotion, you may enter via the following method(s): checking-in with the ESPN LA team at Hollywood Park Casino to be registered on the official entry list, and if an entrant submitted an RSVP at ESPNLA.com, they would be eligible for one (1) bonus entry.
 - i. To participate in the Promotion, you may go to Hollywood Park Casino, 3883 W Century Blvd, Inglewood, CA 90303 beginning Monday, April 7, 2025 at 3:00 PM PT and ending at Monday, April 7, 2025 at 5:00 PM PT (“Entry Period”)and complete an official entry form (while supplies last) including first and last name, complete address, city, state, zip code, date of birth, and submit the entry via online form. All entries must be received by Monday, April 7, 2025 at 5:00 PM PT. GKB is not responsible for lost, stolen, mangled, misdirected, postage due, illegible, incomplete or late entries.
 - ii. To participate in the Promotion, you may log onto ESPNLA.com beginning on Monday, March 24, 2025 at 9:00 AM PT and ending on Sunday, April 6, 2025 11:59 PM PT and follow the links and instructions to enter the Promotion and submit your first and last name, zip code, telephone number, date of birth and a valid email address in the online entry form. Only filling out the RSVP form is not considered a valid entry into the Promotion until the entrant confirms check-in upon arrival at the Event on Monday, April 7, 2025, during the Entry Period.
 - iii. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to

automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by GKB. GKB's computer is the official time keeping device for the Promotion. GKB is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems. Each entrant must agree to GKB's online submission release in order to submit his or her entry.

- c. Only one (1) entry per person upon check-in at the ESPN LA table. Two (2) entries maximum per person – one (1) entry upon check-in and one (1) via RSVP on ESPNLA.com

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who: (i) are 21 years of age or older; and (ii) are legal U.S. residents who currently reside within one of the following California counties: Los Angeles, Ventura, San Bernardino, Orange or Riverside ("Eligibility Area"). Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Entrants are eligible to win a prize in a promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. Each potential winner must provide valid government-issued photo identification, his or her complete address, date of birth and phone number, and sign required winner affidavits to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. Subject to compliance with all of the terms and conditions of these Official Rules, one (1) winner will each be eligible to receive the grand prize (the "Prize") consisting of:
 - (1) two (2) tickets to a wrestling event at Allegiant Stadium on April 19, 2025 in Las Vegas ("Prize Experience")
 - (2) U.S. domestic or international round-trip coach class airfare (from a major gateway city near winner's home as determined by GKB in its sole discretion) for winner and one (1) guest of winner to Las Vegas, Nevada for the Prize Experience
 - (3) one (1) double-occupancy hotel room for one (1) night hotel for the winner and winner's guest at a hotel in Las Vegas to be determined by GKB in its sole discretion. Dates of stay to be determined by GKB in its sole discretion

The Approximate Retail Value (“ARV”) of each prize is \$1,945.00 maximum. If the winner cannot attend on the date(s) specified by GKB or its prize providers, the winner may be disqualified and an alternate winner may be selected in GKB’s sole discretion. Travel arrangements must be made through GKB. Prize is subject to availability. If the winner cannot travel on dates specified by GKB only as a result of time restrictions to obtain required travel documentation. Each winner’s guest must be at least twenty-one (21) years of age and must not be prohibited from participating in this Promotion or the Prize Experience. Certain travel restrictions may apply. All other costs not specifically stated herein, including but not limited to those of, taxes (if applicable), visa/ESTA, meals, tips and ground transportation to/from the airport and/or to/from the hotel, are the responsibility of the winner and the winner’s guest. The winner and winner’s guest must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, any required visa/ESTA and passports for international travel. If applicable, the winner may be required to present a valid credit card upon hotel check-in to cover any incidental expenses incurred during the winner’s stay. The winner and winner’s guest must sign a Publicity, Liability Waiver and Travel Release form prior to traveling (each such document being a restatement and confirmation of certain aspects of these Official Rules). If a selected event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, or for any reason beyond the control of the Station, the Station’s sole responsibility to the winner will be to award the remaining available portion of the prize and no substitution or compensation will be provided for the unawarded portion of the prize. GKB reserves the right to remove or to deny entry to the winner and/or travel companion(s) if either engages in a disruptive manner or with intent to annoy, abuse, threaten or harass any other person at the Wrestling event at Allegiant Stadium.

- b. All prizes will be redeemed via email instruction. The winner will forfeit any prize or prize certificate not claimed within thirty (30) minutes of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- c. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes in the event of unavailability. The Prize is expressly limited to the item(s) listed above and unless otherwise expressly specified, does not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB with respect to the Promotion are final.
- b. GKB will randomly select and contact one (1) potential winner by Monday, April 7, 2025 5:30 PM PT.

- c. Odds of winning the Prize depend upon the number of eligible entries received.
- d. Each winner must execute and return any required affidavit of eligibility and/or liability/publicity release within thirty (30) minutes of winning or prize will be forfeited and an alternate winner may, in GKB's sole discretion, be selected by the same method as above. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. Each winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by GKB in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.
- b. By participating in the Promotion, the winner agrees to have the winner's name, image, photograph, video, voice and likeness used in any publicity, advertising or broadcasting material relating to the Promotion in any and all media worldwide in perpetuity without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the Prize.
- c. Prior to awarding any prize(s) or prize certificate(s), GKB, in its sole discretion, may require Promotion winner(s) (and any travel companion(s) or guest(s)) to sign a liability release, agreeing to release and hold harmless GKB, its subsidiary and affiliated entities, their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns from and against any and all claims or liability arising directly or indirectly from the prize and participation in the Promotion.
- d. If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of GKB that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, GKB reserves the right to cancel, terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a participant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or

committed fraudulent activity in connection with the Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future promotions and to prosecute and seek damages to the fullest extent permitted by law.

- f. GKB reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of GKB or its prize providers, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, GKB reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Promotion and shall not be required to award a substitute prize.
- g. GKB is not responsible for typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize.
- h.
