

Underwear Overshare Giveaway

OFFICIAL RULES

Contest

ESPN Wisconsin will execute a giveaway to one winner per weekday (Monday-Friday) to receive three (3) pairs of Duluth Trading Company underwear. Listeners of WTLX 100.5 ESPN FM and WKTJ 94.5 ESPN FM, and followers of @WildeAndTausch on Twitter can enter for the chance to win by calling in to Wilde and Tausch between 9AM and 12PM every weekday or by tweeting a reason as to why you deserve and/or need a three new pairs of underwear and tagging @WildeAndTausch and using #UnderwearOvershare. Jason Wilde, Mark Tauscher, and Jesse Nelson will collectively decide on a winner each day between 9 AM CST and 12PM CST. Entries must be submitted between 9AM CST and 12PM CST every weekday from Monday, June 3, 2019 to Friday, June 14, 2019.

1. HOW TO ENTER

- a. These rules govern the Underwear Overshare Giveaway promotion (the "Promotion") being conducted by WTLX 100.5 ESPN FM 15 N Pickney St., Suite 100, Madison, WI 53703 ("GKB") beginning on June 3rd, 2019 and ending on June 14th, 2019 between 9AM and 12PM every weekday.
- b. To participate in the Promotion, you may enter via the following method(s):
 - Cue to Call during on-air local programming
 - i. To participate in the Promotion, you must listen to WTLX 100.5 ESPN FM or WKTJ 94.5 ESPN FM each weekday (Monday-Friday) beginning on June 3rd, 2019 and ending on June 16th, 2019 between the hours of 9 AM and 12 PM in the Central Standard Time Zone during the Promotion dates. Upon hearing the initial announcement of the Underwear Overshare Giveaway contest on Wilde and Tausch, call in to get through to the GKB contest line at (844) 770-3776 for WTLX for your chance to win three (3) pairs of Duluth Trading Company underwear, upon confirmation of eligibility. At the time of the call, callers will be asked to share why they deserve and/or need three new pairs of underwear, as well as provide all necessary information in order to be contacted if chosen as a winner; this includes first name, last name, phone number, and email address. In the event that the caller is disconnected or is found to be ineligible, we will take the next eligible caller that successfully makes it through on the call-in line. There is no limit to the number of times a

- listener may attempt to call in to win, but a listener may be a winner only once. There will be up to a total of 10 winners selected on-air during the Promotion dates and times. GKB is not responsible for telephone service outages, delays, busy signals, equipment malfunctions or any other technological difficulties that may prevent an individual from completing his/her telephone call. Due to delays in the GKB online streaming of its broadcast signal, listeners to the online stream may not be able to participate in or may be disadvantaged in participating in on-air contests.

If you do not already "Follow" the Page, the you must "Follow" the Page in order to participate in the Promotion. Tweet the reasoning of why you deserve and/or need three new pairs of underwear and tag the @WildeAndTausch account, as well as #UnderwearOvershare to enter. You must tweet your photo between the hours of 9 AM CTS and 12PM CTS every weekday between Monday, June 3, 2019 and Friday, June 14, 2019. You must have a valid Twitter account in order to enter. If you do not already have one, you can create a Twitter account at no cost by visiting <http://www.twitter.com>. Limit one (1) entry per eligible person during the Entry Period regardless if entrant has more than one email address or Twitter account. Multiple participants are not permitted to share the same email address or Twitter account. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by GKB. Internet entrants are subject to all notices posted online including but not limited to GKB's Privacy Policy. 2. ELIGIBILITY RESTRICTIONS

Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, other radio stations in the Madison and Milwaukee metropolitan areas and the members of their immediate

families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

The Approximate Retail Value ("ARV") of the three (3) pairs of Duluth Trading Company underwear is \$45. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- b. All prizes or prize certificates may be picked up at the office of GKB at these addresses: 15 N Pickney St., Suite 100, Madison, WI 53703. The winner will forfeit any prize or prize certificate not claimed within forty-five (45) days of winning. GKB is not responsible for the safe arrival of a prize or prize certificate.
- c. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.

- b. One winner will be selected every weekday that the Promotion runs. Prize is determined on how well the reasoning as to why you deserve and/or need three new pairs of underwear is. Jason Wilde, Mark Tauscher, and Jesse Nelson will collectively decide on the winner of the day. If chosen as a winner, you will be contacted via phone, email, or Twitter.
- c. Odds of winning a prize depends on your reasoning as to why you deserve and/or need three new pairs of underwear.
- d. Qualifiers must listen to WTLX 100.5 ESPN FM or WKTI 94.5 ESPN FM to win. Prize winner need not be present to win.
- e. Winners will be notified by an employee of GKB by the phone number they provided to the show producer. They will be informed within 72 hours of being selected the winner. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited and an alternate winner may be selected by running the promotion again on a different day. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
