OFFICIAL RULES

CONTEST OVERVIEW

Want a chance to win some of Mike Tannenbaum's cold, hard cash?! Well now's your chance thanks to Grieco Chevy! Every week, we'll pick on lucky fan to go head-to-head against Mike in a game of Fantasy Football. If you win, you get the cash. If Mike wins, it rolls over to the next week.

1. HOW TO ENTER

These rules govern the "Weekend Warriors" promotion (the "Promotion") being conducted by WUUB 106.3 ESPN 777 S. Flager Drive, Suite 106, West Palm Beach, Florida, 33401 and ("GKB") beginning on Thursday, October 7, 2022 at 9AM ET and ending on Friday, December 30, 2022 at 6PM ET.

- a. To participate in the Promotion, you may enter via the following method(s):
 - i. To participate in the Promotion, you may call into Ken LaVicka Live (ESPN 106.3FM, weekdays 12-2pm) on **Thursday's** after hearing the cue to call starting on Thursday, October 7, and ending on Thursday, December 29th, 2022. Four callers will be selected as qualifiers. Ken will pick a football position (i.e. quarterback, wide receiver, tight end, etc.) and find the top five projected highest producers for that given week per ESPN Fantasy. Each caller with pick a player, no two callers may pick the same player. Once that player is taken, they are no longer eligible for other callers to choose. Ken will "take" the last player available. The person with the highest scorer after Monday Night Football, wins a \$50 Stormhouse gift card. If Ken wins for the week, the \$50 gift card will roll over into the following week. GKB is not responsible for lost, stolen, mangled, misdirected, postage due, illegible, incomplete or late entries.
 - ii. Show times are subject to change based on breaking news and specialty content at the discretion of GKB. GKB has the right to not notify fans and to not update contest rules or the webpage when such situations occur.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are the age of 18 years and above and reside in Florida. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, other radio stations in

the Treasure Coast area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.

 - If Ken LaVicka wins the weekly fantasy, the \$50 gift card will roll over into the “pot” for the following week.

The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

b. All prizes or prize certificates may be picked up at the office of GKB at one of the following addresses depending on the prize:

- a. Decisions of GKB management with respect to the Promotion are final.
- b. Winners will be randomly selected each week from the pool of entrants who completed the online form. All decisions in terms of prizing are determined by GKB.
- c. Odds of winning a prize depends upon the number of online entries and your ability to score more fantasy points than Mike Tannenbaum.
- d. Qualifiers must complete the online form and Fantasy League by specified date to win. Prize winners need not be present to win.
- e. Winners will be notified by an employee of GKB by the phone number or email they provided to the show producer. They will be informed within 72 hours of being selected the winner. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited and an alternate winner may be selected by running the promotion again on a different day. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).

e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
